AN ORDINANCE EXTENDING THE FILING/RENEWAL OF BUSINESS PERMITS AND THE PAYMENT OF ALL LOCAL TAXES, FEES AND OTHER CHARGES WITHOUT PENALTY UP TO THE CLOSING HOURS OF FEBRUARY 15, 2022

WHEREAS, Section 167 of Republic Act No. 7160, otherwise known as the Local Government code of 1991, provides that, "**xxx all local taxes, fees and charges shall be paid within the first twenty (20) days of January or of each subsequent quarter, as the case may be. The Sanggunian concerned may, for a justifiable reason or cause, extend the time of payment of such taxes, fees, or surcharges or penalties but only for a period not exceeding six (6) months**";

WHEREAS, the **Business Permit and Licensing Office (BPLO)**, once again, requested for the extension of time of filing and renewal of permits, noting the economic impact of Covid-19 pandemic and taxpayers may not be able to immediately comply with the mandatory and requisite documents which are the basis for the prudent and correct imposable taxes;

WHEREAS, extending the deadline in filing and renewal of business permit from **January 20 to February 15, 2022** to accommodate the request of the Business Permits and Licensing Office in behalf of the taxpayer, the majority of whom, financially, were affected by the pandemic;

NOW, THEREFOR, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by 9th Sangguniang Panlungsod, to extend the filing/renewal of Business and Tricycle Permits and the payment of all local taxes, fees and other charges without penalty up to the closing hours of **February 15, 2022**.

ENACTED, by the 9th Sangguniang Panlungsod of Muntinlupa, this 17TH day of January, 2022, on its 132nd Regular Session.
