WHEREAS, on January 22, 2022, the Sangguniang Panlungsod enacted Ordinance 2022-314 otherwise known as an Ordinance Institutionalizing the Expanded Benefits of the Pantawid Pamilyang Pilipino Program (4ps) Beneficiaries in the City Of Muntinlupa;

WHEREAS, Ordinance 2022-314 was enacted with the rationale of empowering the poor, vulnerable and disadvantaged constituents of Muntinlupa particularly those who have qualified in the 4Ps program of the national government;

WHEREAS, to effectively implement the provisions of Ordinance 2022-314, the Family Development Session (FDS) Team under the created subcommittees/ team to support the Local Advisory Council was created to function as an intervention/services;

WHEREAS, studies showed that drug-related poverty is prevalent in the 4Ps household so much so that the need to include the DAPCO as one of the members of the FDS Team is necessary;

NOW THEREFORE, BE ENACTED, by the 10th Sangguniang Panlungsod of Muntinlupa, to reconstitute the Composition of the Family Development Session (FDS) Team by the inclusion of the Drug Abuse Prevention and Control Office (DAPCO) thereby amending Ordinance No. 2022-314 otherwise Known as the expanded Pantawid Pamilyang Pilipino Program (4Ps) of the City of Muntinlupa.
