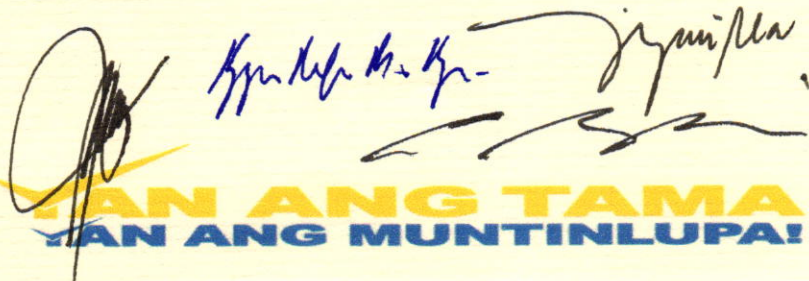
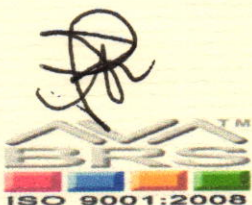

WHEREAS, Section 454 (d) of Republic Act No. 7160 otherwise known as the "Local Government Code of 1991", on Officials of the City Government, states that **"Unless otherwise provided herein, heads of departments and offices shall be appointed by the city mayor with the concurrence of the majority of all the Sangguniang Panlungsod members, subject to civil service law, rules and regulations. The Sangguniang Panlungsod shall act on the appointment within fifteen (15) days from the date of its submission, otherwise the same shall be deemed confirmed;"**

WHEREAS, the mandate of the **Committee on Personnel Administration** under Rule VIII(s) of the Internal Rules of Procedure for the **10th Sangguniang Panlungsod** to confirm all appointments made by the Hon. City Mayor; is derived from **Article III, Section 8(d) of Republic Act 7926**, otherwise known as the **"Charter of the City of Muntinlupa"** which provides as follows:

"Unless otherwise provided herein, all appointed city officials of the city shall be appointed by the City Mayor with the concurrence of the majority of all the Sangguniang Panlungsod Members, subject to Civil Service Law, Rules and Regulations. The Sangguniang Panlungsod shall act on the appointment within fifteen (15) days from the date of its submission, otherwise the same shall be deemed confirmed"

WHEREAS, Section 458 (a) (1)(viii) of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that, "**The Sanggunian Panlungsod shall "determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide for expenditures necessary for the proper conduct of programs, projects, services and activities of the city government"**";

WHEREAS, Section 8 (d), Article III of Republic Act No. 7926 otherwise known as the "Charter of the City of Muntinlupa", provides that, "**Unless otherwise provided herein, all appointive City Officials of the City shall be appointed by the City Mayor with the concurrence of the majority of all the Sangguniang Panlungsod members, subject to the civil service law, rules and regulations The Sangguniang Panlungsod shall act on the appointment within fifteen (15) days from the date of its admission, otherwise the same shall be deemed confirmed.**";

WHEREAS, the **Hon. City Mayor Rozzano Rufino B. Biazon**, as the appointing authority, has recommended the appointment of **Engr. Allan A. Cachuela** as **Department Head II (City Administrator)** at the **Office of the City Administrator** of the City Government of Muntinlupa and has submitted the same for the confirmation by the City Council;

WHEREAS, **Engr. Allan A. Cachuela**, finished his Primary Education at Tunasan Elementary School in 1981 and Secondary Education at Sacred Heart Institute in 1985, graduated at University of the East with the degree of Bachelor of Science in Civil Engineering 1990 and finished his Master in Business Management at St. Francis of Asisi College in 1999;

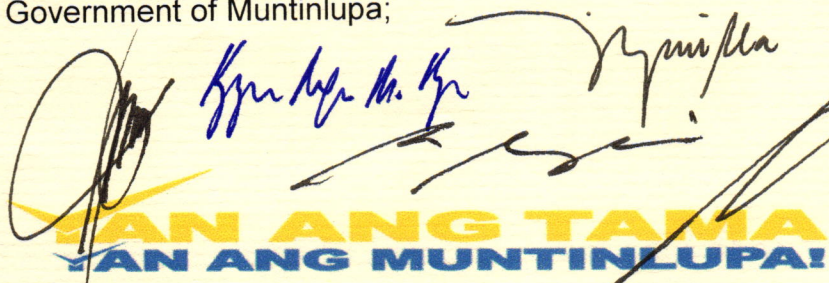
WHEREAS, **Engr. Allan A. Cachuela**, passed the Examinations for the following: **Junior Geodetic Engineering Board Exam**, with a grade of 70.0, **Senior Police Officer** - 75.0, **Police Officer** - 85.76, and **Career Service (Professional)** with a grade of 83.3%;

WHEREAS, **Engr. Allan A. Cachuela**, is a resident of Lot 4, Block 143, F. Makasiar St., Katarungan Village, Barangay Poblacion, Muntinlupa City.

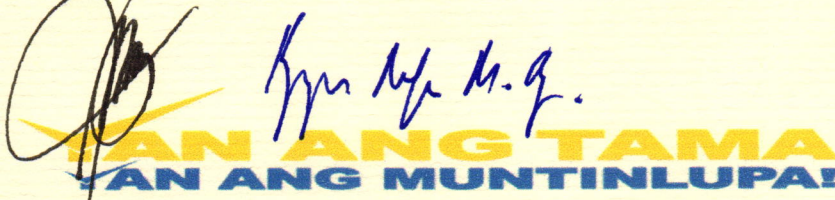
