WHEREAS, Section 16 of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991 (LGC), provides that, **“every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”**;

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing the LGC (LGC-IRR), provides that, **“(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) Exercise general supervision and control over all programs, projects, services, and activities of the City, and in this connection, shall: Xxx (vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.”**;

WHEREAS, Project Roll-Out of RX BOX 1000 Telehealth Devices In Selected Healthcare Facilities is a collaborative project of the DOST, University of the Philippines-Manila – National Telehealth Center (UP-NTHC), University of the Philippines Diliman – College of Engineering, DOST - Advanced Science and Technology Institute, and the Department of Health (DOH) where a telemedicine device that aims to bring significant advancement to the country's community healthcare initially planned to be distributed in rural areas;

WHEREAS, the RxBox project aims to provide identified Geographically Isolated and Disadvantaged Areas (GIDAs) a medical device that can be used for diagnostic procedures as well as an Electronic Medical Record (EMR) which can be utilized for the storage and referral of clients' medical records;

WHEREAS, the RxBox Telehealth device, composed of six (6) medical sensors which include a Cardiotocograph (CTG), Fetal Heart Rate Monitor, Electrocardiogram (ECG), Blood Pressure Monitor, Pulse Oxymeter, and a Temperature sensor, is on the lent-basis and after three (3) months the device may be donated to the LGU concerned after evaluation of DOST-NCR;

WHEREAS, the **Tunasan Health Center** located at Centennial Avenue Barangay Tunasan was selected as the healthcare facility to provide operational and administrative support in the implementation of the project;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the **10th Sangguniang Panlungsod of Muntinlupa,** to authorize the **Hon. City Mayor Rozzano Rufino B. Biazon** to represent Muntinlupa in A Memorandum Of Agreement (MOA) with the Department Of Science And Technology(DOST)-NCR represented by its Regional Director Jose B. Patalinjug III and Department Of Health-Metro Manila Center For Health Development (DOH-MMCHD) represented by its Regional Director, Dr. Gloria J. Balboa on the implementation of the Project Roll Out Of Rx Box 1000 Telehealth Devices In Selected Healthcare Facilities In The Philippines.”
