WHEREAS, Section 2 Article XII of the 1987 Constitution provides, "All lands of the public domain, waters, minerals, coal, petroleum, and other mineral oils, all forces of potential energy, fisheries, forests or timber, wildlife, flora and fauna, and other natural resources are owned by the State. With the exception of agricultural lands, all other natural resources shall not be alienated. The exploration, development, and utilization of natural resources shall be under the full control and supervision of the State. The State may directly undertake such activities, or it may enter into co-production, joint venture, or production-sharing agreements with Filipino citizens, or corporations or associations at least sixty per centum of whose capital is owned by such citizens".;

WHEREAS, Section 27 of the Local Government Code of 1991 provides for prior consultations requirement, thus: "No project or program shall be implemented by government authorities unless the consultations mentioned in Sections 2 (c) and 26 of the same code are complied with, and prior approval of the Sanggunian concerned is obtained: Provided, That occupants in areas where such projects are to be implemented shall not be evicted unless appropriate relocation sites have been provided, in accordance with the provisions of the Constitution";

WHEREAS, one of the centerpiece of the Duterte administration is the Build, Build, Build Program where the DPWH is one of the implementing arms and is tasked to promote and advance the development of an efficient and coordinated infrastructure system;

WHEREAS, the **Laguna Lakeshore Road Network (LLRN) Project** is one of the seven projects under the **Infrastructure Preparation and Innovation Facility (IPIF)** which aims to support the **Department of Public Works and Highways (DPWH)** to deliver more effective, efficient and innovative infrastructure projects all over the country. LLRN caters the area in the vicinity of Laguna de Bay, with a road network scheme that is divided into two phases: **Phase 1** runs along the western coastline of the Lake while **Phase 2** stretches in the Northern to Southern coastline via an eastern route;

WHEREAS, the DPWH-NCR, through **Bids and Awards Committee Resolution No. 0040-2021** declared **CT Leoncio Construction and Trading** as the contractor for the Network Development-Construction of Missing Links/New Roads-Laguna Lake Highway Extension (Phase 1), **Muntinlupa City**;

WHEREAS, the project as envisioned will provide a road corridor to facilitate traffic flow from **Metro Manila** to the province of **Laguna in Region IV**;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the **10th Sangguniang Panlungsod of Muntinlupa**, to interpose no objection to the project Network Development-Construction of Missing Links/New Roads-Laguna Lake Highway Extension Muntinlupa City.
