AN ORDINANCE APPROVING THE UTILIZATION OF LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND AND ANNUAL INVESTMENT PLAN CONTAINING THE PROGRAM FOR THE PORTION OF UNEXPENDED BALANCE OF THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT (LDRRM) SPECIAL TRUST FUND (STF) FOR THE YEAR 2021 IN THE AMOUNT OF SEVENTY-TWO MILLION THREE HUNDRED TWENTY-FIVE THOUSAND SEVEN HUNDRED FORTY-EIGHT PESOS (PHP72,325,748.00)

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, "every Local Government Unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;"

WHEREAS, Section 2(l) of the Philippine Disaster Risk Reduction and Management Act of 2010 (R.A. No. 10121) declares that, "it is the policy of the State to recognize and strengthen the capacity of the LGUs and communities in mitigating and preparing for, responding to, and recovering from the impact of disasters,";

WHEREAS, Section 21 of R.A. No 10121 provides that, "the creation of the local calamity fund known as the Local Disaster Risk Reduction and Management Fund (LDRRMF) to support disaster risk management activities. Further, the unexpended LDRRMF shall accrue to a special trust fund solely to support said activities within the next five (5) years";

**WHEREAS**, paragraph 2.5.6 of Department of Budget and Management (DBM) LBC No. 2020-124 pursuant to Section 21 of R.A. No. 10121 and its Implementing Rules and Regulations (IRR), Commission on Audit (COA) Circular No 2012-002, and National Disaster Risk Reduction and Management Council-Department of Budget and Management-Department of Interior and Local Government (DILG) Joint Memorandum Circular (NDRRMC-DBM-DILG JMC) No. 2013-01, states that, **"The unexpended balances of the LDRRMF that accrued to the special trust fund pursuant to Section 21 of R.A. No. 10121 may be used to address the disaster response requirements of the COVID-19 emergency, among other purposes sanctioned by law, provided that the same is consistent with the approved LDRRM Plan as incorporated in the Annual Investment Plan (AIP)";**

**WHEREAS**, paragraph 65 of the NDRRMC-DBM-DILG JMC No. 2013-01 provides that, **"The unexpended balances of the LDRRMF may be released and utilized for new expenditure items as approved by the local Sanggunian and Local Chief Executive upon recommendation of the Local Disaster Reduction and Management Office (LDRRMO)";**

**WHEREAS**, in an endorsement dated September 1, 2022 the **City Mayor Rozzano Rufino B. Biazon** submitted to the Sanggunian the proposed LDRRM Fund and Annual Investment Plan to utilize a portion of available balance of the **LDRRM Special Trust Fund (STF)** as of **2021** amounting to **Seventy-Two Million Three Hundred Twenty-Five Thousand Seven Hundred Forty-Eight Pesos (Php72,325,748.00)** for: *Disaster Preparedness Programs; Disaster Mitigation Program, Disaster Response Program, Disaster Recovery and Rehab Program;*
