AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 2 FOR FY 2022 OF BARANGAY ALABANG, AMOUNTING TO FIVE MILLION PESOS (PHP5,000,000.00) TO BE TAKEN FROM THE DEPARTMENT OF BUDGET AND MANAGEMENT OF NATIONAL GOVERNMENT – (LOCAL GOVERNMENT SUPPORT FUND-OTHER FINANCIAL ASSISTANCE (LGSF-FA))

WHEREAS, Article 99, (1)(i) of Rules and Regulations Implementing the Local Government Code of 1991, states that, "The Sangguniang Panlungsod as the Legislative Body of the city shall enact ordinances, approve resolutions and appropriate fund for the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, xxx, as one of the corporate powers of the city as provided in Rule IX of these rules, and shall:

(i) "Review all ordinances approved by the Sangguniang Barangay and executive orders issued by the Punongbarangay to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Punongbarangay.";

WHEREAS, the Budget Office endorsed and recommended to the Sangguniang Panlungsod the Supplemental Budget No. 2 of Barangay Alabang amounting to Five Million Pesos (Php5,000,000.00);

WHEREAS, the Budget and Management Department thru its Head, Mr. Necito M. Guico endorsed and recommended the approval of the Barangay Alabang 2022 Supplemental Budget No. 2 as it has complied with the rules, and regulations, and pertinent laws on budget;

WHEREAS, the sources of Supplemental fund of Barangay Alabang came from the Department of Budget and Management of National Government – (Local Government Support Fund-Other Financial Assistance (LGSF-FA):

WHEREAS, the Supplemental Budget No. 2 is allocated, as follows:

WHEREAS, the Capital Outlay (CO) shall be allocated as follows:

WHEREAS, the Supplemental Appropriation Ordinance No. 07-02, series of 2022, dated August 22, 2022 is recommended **to be declared operative** in its **entirety**, subject to conditions herein, **effective immediately**. This show substantial compliance with the same law and its implementing rules and regulations (IRR) but still subject to the posting requirements under Section 59 of R.A. No. 7160.

WHEREAS, the disbursement thereof shall be in accordance with the existing Budgeting, Accounting and auditing rules and regulations as well as the established compensation laws, rules, policies and guidance.

WHEREAS, all procurement of goods, supplies and materials, equipment and infrastructure/civil works shall be subject to the pertinent provision of R.A No. 9184 (Government Procurement Reform Act) and its Revise Implementing Rules and Regulations (IRR) and prior clearances from pertinent agencies as maybe appropriate /needed. In addition, all procurement shall be included to the duly approved Annual Procurement Plan (AIP);

WHEREAS, the budget shall be available exclusively for the specific purposes for which they have been appropriated and shall be spent solely for public purposes. Thus, no monies shall be paid out of Treasury except in pursuance of an Appropriation Ordinance or Law;

NOW THEREFORE, BE IT ENACTED, by the **10th Sangguniang Panlungsod of Muntinlupa**, to approve the **Supplemental Budget No. 2** for FY 2022 of **Barangay Alabang**, amounting to **Five Million Pesos (Php5,000,000.00)** to be taken from the **Department of Budget and Management (DBM)** of National Government – (Local Government Support Fund-Other Financial Assistance (LGSF-FA).
