ORDINANCE NO. 2022-020

AN ORDINANCE GRANTING FINANCIAL ASSISTANCE AMOUNTING TO FIVE THOUSAND PESOS (PHP5,000.00) PER FAMILY WHO WILL BE AFFECTED BY THE CONSTRUCTION OF A NEW CITY JAIL UNDER THE ADMINISTRATION OF THE BUREAU OF JAIL MANAGEMENT AND PENOLOGY (BJMP) LOCATED AT LAS VEGAS, BARANGAY PUTATAN, MUNTINLUPA CITY WHICH AMOUNT SHALL BE TAKEN FROM 2022 EXECUTIVE BUDGET UNDER THE SOCIALIZED HOUSING, LANDBANKING, COMMUNITY MORTGAGE PROGRAM AND OTHER RELATED ACTIVITIES UNDER THE NON-OFFICE MOOE

WHEREAS, Section 458 (a) (1) (iv) of the Local Government Code of 1991 states that, **“the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, adopt resolutions and appropriate funds for the general welfare of the city and its inhabitants xxx”;**

WHEREAS, Section 5 of Republic Act No. 7279 otherwise known as the Urban Development and Housing Act of 1992, lists among others the lands which are exempt from the coverage of this RA 7279, x x x **Those used, reserved or otherwise set aside for government offices, facilities and other installations, whether owned by the national government, its agencies and instrumentalities, including government-owned or -controlled corporations, or by the local government units:**

WHEREAS, on February 8, 2021, Sanggunian Resolution 2021-414 authorized the **Local Chief Executive** to enter into a **Memorandum Of Agreement (MOA)** with the **Bureau of Jail Management and Penology (BJMP)** Muntinlupa for the usufruct of the property owned by the City Government of Muntinlupa with an area of 5,647 square meters more or less located at Barangay Putatan, Muntinlupa City for the purpose of housing **Persons Deprived Of Liberty (PDL)**;

WHEREAS, as a consequence of the construction of the proposed new city jail, eleven (11) **Informal Settler-Families (ISFs)** residing at the jail site will be affected and will need to be transferred and relocated. However, the said ISFs were not listed in the UDHA Masterlist of Potential Beneficiaries as certified by the head of the Urban Poor Affairs Office (UPAO) and therefore not qualified to receive compensation/grant as provided by the UDHA law;

NOW BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the 10<sup>th</sup> **Sangguniang Panlungsod** the following:

**SECTION 1. Grant of Compassionate/ Humanitarian Financial Assistance.**  
The amount of **Five Thousand Pesos (Php5,000.00)** is hereby granted as compassionate/humanitarian assistance to the following ISFs:

**SECTION 2. Funding.** The total amount of **Fifty Five Thousand Pesos (Php55,000.00)** shall be charged against the 2022 Executive Budget under the Socialized Housing, Land Banking, Community Mortgaged Program and other Related Activities under the Non-Office MOOE;

**SECTION 3. Implementation.** The UPAO shall be charged with the implementation of this ordinance which shall likewise render the necessary report on the matter.






