



ORDINANCE NO. 2022-309

AN ORDINANCE REGULATING THE MOVEMENT OF UNVACCINATED INDIVIDUALS IN THE CITY OF MUNTINLUPA

WHEREAS, Republic Act No. 11332 or the "Mandatory Reporting of Notifiable Diseases and Health Events of Public Health Concern Act" declares that it is the policy of the State "to protect and promote the right to health of the people and instill health consciousness among them" and that the State "recognizes epidemics and other public health emergencies as threats to public health and national security, which can undermine the social, economic, and political functions of the State";

WHEREAS, the Metro Manila Council released MMDA Resolution NO. 22-01 Series of 2022 dated January 3, 2022, "Urging The Metro Manila Local Government Units to Enact Their Respective Ordinances On the Enhanced Restrictions of the Unvaccinated Individuals to Regulate Their Mobility in The National Capital Region, in response to the declaration of the National Capital Region under Alert Level 3 from January 03, 2022 to January 15, 2022 due to the alarming rise in active cases of Covid-19";

WHEREAS, the rationale of the MMDA Resolution No. 22-01 is to sustain the advances in public health and economic gains that have been achieved when NCR was under Alert Level 2 and to pre-empt the adverse impact of the highly-transmissible Omicron variant;

WHEREAS, public awareness of the efficacy of the various vaccines against Covid-19 led to almost one hundred percent (100%) jabs administered to target groups but the unvaccinated individuals who are most prone to infection and likely to contribute to the burdening of the health care system have not gotten their inoculation until now;

WHEREAS, the City of Muntinlupa recognizes the basic freedom of the unvaccinated individuals, however, this same freedom must be balanced by the responsibility of the local government to protect public health, promote general welfare and sustain an improving economy;

NOW THEREFORE, BE IT ENACTED, by the 9th Sangguniang Panllungsod of Muntinlupa in session assembled the following:

SECTION 1. *Title.* This ordinance shall be known as "*Regulating the movement* of Unvaccinated Individuals in Muntinlupa City".

SECTION 2. Definition of terms:

A. Unvaccinated individuals - The term refers to those persons who are not fully vaccinated as defined by the Department of Health (DOH).

SECTION 3. Regulation - All unvaccinated individuals in the City of Muntinlupa

 Remain in their residences at all times except for the procurement of essential goods and services such as, but not limited to, food, water, medicine, medical devices, public utilities, and energy, work, and medical and dental necessities;

Provided, however, that individual outdoor exercises shall be allowed within the general area of their residence, e. g., within the barangay, purok, subdivision, or village;

- Be prohibited in indoor and outdoor/al fresco dining in restaurants and other food establishments and shall likewise be prohibited from leisure or social trips to malls, hotels, event venues, sports and country clubs, and similar facilities;
- Be prohibited in domestic travel via public transportation by land, sea, and air except for the procurement of essential goods and services such as, but not limited to, food, water, medicine, medical devices, public utilities, and energy, work, and medical and dental necessities subject to the production of proof to support and justify such travel;
- Be required to undergo a Reverse Transcription Polymerase Chain Reaction (RT PCR) test every two (2) weeks at their personal expense and present a COVID-19 negative result prior to being admitted for work onsite consistent with the guidelines, rules, and regulations issued by the IATF and the Department of Labor and Employment;

Provided, however, that in the event that the RT PCR test and/or result is/are not immediately available, a Rapid Antigen Test may be utilized in lieu thereof; The foregoing restrictions shall also cover individuals who reside outside of the City of Muntinlupa but who work and/or travel to the City.

SECTION 4. *Penalty*. Any individual and/or establishment found to be in violation of this ordinance shall be penalized with the following:

1. A fine of **Five Thousand Pesos (Php5,000)** or imprisonment of One (1) Year or both at the discretion of the Court; and without prejudice to further prosecution under the provisions of Republic Act No. 11332, particularly Section 9 (d) and (e) on Prohibited Acts in relation to Section 10 on Penalties.

Furthermore, any individual or establishment who or which will falsify the COVID-19 vaccine card shall be prosecuted under Act No. 3815 or the Revised Penal Code, as amended, pursuant to Section 12 of Republic Act No. 11525 or the COVID-19 Vaccination Program Act of 2021

SECTION 5. Vaccination Card/RT PCR TEST requirement: All persons, including all elected and appointed officials and employees of the City Government of Muntinlupa and all Barangay elected and appointed officials and employees, shall be required to present Vaccination Cards or its digitized form or RT/PCR Test Result or its Digitized form showing proof of their full vaccination before entering any government office, building and other facilities or before availing or securing the services of both the City and Barangay.

SECTION 6. *Effectivity.* This Ordinance shall be in force and effect while the COVID-19 alert level in the **National Capital Region (NCR)** is at **Alert Level 3** or higher and shall be automatically lifted once **Alert Level 2** or lower is declared.

ENACTED, by the 9th Sangguniang Panlungsod of Muntinlupa this 10th day of January 2022, on its 131st Regular Session.
