AN ORDINANCE AUTHORIZING THE USE OF THE NINE MILLION THREE HUNDRED SEVENTY-SEVEN THOUSAND THREE HUNDRED ONE PESOS (PHP9,377,301.00) CALAMITY FUND RELEASED BY THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) PURSUANT TO REPUBLIC ACT 11518 IN THE FY 2021 GENERAL APPROPRIATION ACT FOR COVID-19 RELATED PROGRAM PROJECT AND ACTIVIES (PPAs)

WHEREAS, Special Provision (SP) No. 5 of Republic Act 11518 or the General Appropriation Act (GAA) of 2021 states, ***"The amount of Four Billion Five Hundred Million Pesos 4,500, 000,000.00) appropriated herein for the Disaster rehabilitation and Reconstruction Assistance Program for Local Government Units shall be used to aid in the recovery and reconstruction of economy and livelihood in the LGUs that are directly affected by Taal Volcano eruption, Typhoon Quinta, Super Typhoon Rolly and Typhoon Ulysses, as indicated in the situational report issued by the National Disaster Risk reduction management Council: Provided, that shall recovery and reconstruction shall be used for the following project based on the approved local rehabilitation and recovery plans: x-x-x social protection;"***

WHEREAS, on January 20,2021, the Department of Budget and Management (DBM) issued Local Budget Circular (LBC) No. 134, providing for the guidelines on the release and utilization of the Local Government Support Fund Disaster Rehabilitation and Reconstruction Assistance Program (LGSF-DRRAP) in the Fiscal Year 2021 GAA OF 2021;

WHEREAS, Annex B of LBC No. 134 indicated the amount of ***Nine Million Three Hundred Seventy-Seven Thousand Three Hundred One Pesos (Php 9,377,301.00)*** Muntinlupa share under the LGSF-DRRAP;

WHEREAS, on September 8, 2021 the Department of Interior and Local Government issued an Advisory stating the eligibility of Covid-19 PPAs for funding under the LGSF-DRRAP FY 2021 **“as long as the PPAs are also (i) attributed to the recovery and reconstruction of the economy and livelihood of the LGU and (ii) within the eligible program and projects under SP No. 5 of the LGSF in FY 2021 GAA”**;

NOW THEREFORE, BE IT ENACTED, by the 9th Sangguniang Panlungsod of Muntinlupa in session assembled that:

SECTION 1. **Share of the City and the corresponding AIP.** The amount of **Nine Million Three Hundred Seventy-Seven Thousand Three Hundred One Pesos (Php 9,377,301.00)** Muntinlupa share under the LGSF-DRRAP is hereby authorized to be expended for Covid-19 related programs, projects and activities as indicated herein:

SECTION 2. **Trust Fund.** The FY 2021 LGSF-DRRAP shall be recorded as trust fund by the City of Muntinlupa for the specific purpose for which the fund were received and shall be made available for disbursement for the purpose specified until December 31, 2022.

SECTION 3. **Project Implementation.** Disbursement and utilization of the FY 2021 LGSF-DRRAP shall comply with the provisions of LBC 134 dated January 20, 2021, Republic Act 9184 or the Government Procurement Reform Act, its implementing rules and regulations, as well as applicable budgeting, accounting and auditing rules and regulations.

SECTION 4. **Compliance with Posting and Reporting Requirements.** The City shall comply with the mandated posting and reporting requirement setforth under LBC No 134.

SECTION 5. **Separability Clause** – If, for any reason or reasons, any part or provisions of this ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.


SECTION 6. Repealing Clause. All previous ordinances inconsistent with this ordinance shall be deemed repealed or modified accordingly.


SECTION 7. Effectivity Clause – This ordinance shall take effect immediately after its approval.

ENACTED, by the 9th Sangguniang Panlungsod of Muntinlupa this 14th day of March 2022, on its 140th Regular Session.


