ORDINANCE NO. 2022-347

AN ORDINANCE GRANTING THE FINANCIAL ASSISTANCE IN THE TOTAL AMOUNT OF THIRTY-ONE THOUSAND PESOS (PHP31,000.00) TO THE ADDITIONAL AFFECTED FAMILIES OF FIRE THAT TRANSPIRED ON 24 MARCH 2022 AT 7C ILAYA STREET, BARANGAY ALABANG, MUNTINLUPA CITY, WHICH AMOUNT SHALL BE TAKEN FROM THE 2022 EXECUTIVE BUDGET UNDER 5% MUNTINLUPA CITY RISK REDUCTION DISASTER AND MANAGEMENT FUND (MCRRDMF)

WHEREAS, Section 458(a)(1)(iv) of Republic Act No. 7126, otherwise known as the "Local Government Code of 1991," on the Powers, Duties, Functions, and Compensation of the Sangguniang Panlungsod, states that "[T]he Sangguniang Panlungsod, as the legislative body of the City, shall enact ordinances, approve resolutions, and appropriate funds for the general welfare of the City and its inhabitants pursuant to Section 16 of this Code and in the proper exercise of the corporate powers of the City as provided for under Section 22 of this Code, and shall: (1) Approve ordinances and pass resolutions necessary for an efficient and effective city government and in this connections, shall: Xxx. (iv) Adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said event;"

WHEREAS, on 24 March 2022, a fire gutted at 7C Ilaya Street, Barangay Alabang, Muntinlupa City, and greatly affected number of families and rendered them homeless;

WHEREAS, on 25 March 2022, the Sangguniang Panlungsod ng Muntinlupa enacted City Ordinance No. 2022-340 entitled "An Ordinance Granting Financial Assistance in the Total Amount of Five Hundred Thirty-Four Thousand Pesos (PhP534,000,000) to the Affected Families of Fire that Transpired on 24 March 2022 at 7C Ilaya Street, Barangay Alabang, Muntinlupa City, which Amount shall be Taken from the 2022 Budget under the 5% Muntinlupa City Risk Reduction Disaster and Management Fund (MCRRDMF);"

WHEREAS, on 29 March 2022, the Social Services Department (SSD) of the City, after thorough assessment and evaluation, recommended the additional beneficiaries affected by the conflagration to receive financial assistance, and with the following justifiable humanitarian reasons:

- (1) Legitimate residents who stayed with their relatives outside Muntinlupa City after the incident to safe keep their children and elderly family members;
- (2) Not aware of the listing from the City that includes partially damaged structures; and
- (3) Water damaged and stolen appliances during the event of the fire.

NOW THEREFORE, BE IT ENACTED, by the 9th Sangguniang Panlungsod in Session assembled that:

SECTION 1. Title. This Ordinance shall be known as the "Ordinance Granting Financial Assistance in the Total Amount of Thirty-One Thousand Pesos (PhP31,000.00) to the Additional Affected Families of Fire that Transpired on 24 March 2022 at 7C Ilaya Street, Barangay Alabang, Muntinlupa City."

SECTION 2. Affected Families/Individuals. The Social Services Department (SSD) of the City provided additional beneficiaries affected by the fire that gutted on 24 March 2022 at 7C Ilaya Street, Barangay Alabang, Muntinlupa City, including the list of families and individuals greatly affected thereby, as follows:

The list of additional beneficiaries from the SSD shall form part of this Ordinance.

SECTION 3. Compliance with Omnibus Election Code. In cases of occurrence of a calamity or disaster, all releases normally or usually coursed through the SSD shall be turned over to, and administered and disbursed by, the Philippine National Red Cross, subject to the supervision of the Commission on Audit or its representatives, and no candidate or his or her spouse or member of his family within the second civil degree of affinity or consanguinity shall participate, directly or indirectly, in the distribution of any relief or other goods to the victims of the calamity or disaster (*In re: Section 261[v], Article XXII of the Batas Pambansa Blg. 881 or the "Omnibus Election Code," on the prohibition against release, disbursement, or expenditure of public funds*).

SECTION 4. Budget. The financial assistance in the total amount of **Thirty-One Thousand Pesos (Php31,000.00)** to the affected families and individuals shall be taken from the **2022 Executive Budget** under the **five percent (5%) Muntinlupa City Risk Reduction Disaster and Management Fund (MCRRD MF)**.

SECTION 5. Publication and Dissemination. The Ordinance shall be published pursuant to the requirements of the Local Government Code and shall be posted in the Official Website of the City Government of Muntinlupa. The **Public Information Office (PIO)** shall disseminate copies of this Ordinance in all available social media platforms.

SECTION 6. Separability Clause. If any portion of this Ordinance is declared invalid, the remainder of this Ordinance shall not be affected and shall remain valid and enforceable.

SECTION 7. Repealing Clause. All ordinances, rules and regulations or part thereof where provisions are in conflict or contrary to the provisions of this Ordinance are hereby repealed, amended, or modified accordingly.

SECTION 8. Effectivity. This Ordinance shall take effect upon its approval.
