NOW THEREFORE, BE IT ENACTED, by the 9th Sangguniang Panlungsod of Muntinlupa, to approve the Barangay Budget for FY 2022 of Barangay Tunasan amounting to Ninety-Three Million Five Hundred Thousand Pesos (Php93,500,000.00).
