WHEREAS, all procurement of goods, supplies and materials, equipment and infrastructure/civil works shall be subject to the pertinent provision of R.A No.9184 (Government Procurement Reform Act) and its Revised IRR; and prior clearances from pertinent agencies as maybe appropriate /needed. In addition, all procurement shall be included to the duly approved Annual Procurement Plan;

WHEREAS, the herein barangay budget shall be available exclusively for the specific purposes for which it has been appropriated and shall be spent solely for public purposes. Thus, no monies shall be paid out of Treasury except in pursuance of an Appropriation Ordinance or Law;

NOW THEREFORE, BE IT ENACTED, by the 9<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to approve the Barangay Budget for FY 2022 of Barangay Tunasan amounting to **Ninety-Three Million Five Hundred Thousand Pesos (Php93,500,000.00)**.
