WHEREAS, Article 99, (1)(i) of Rules and Regulations Implementing the Local Government Code of 1991, states that, "the Sangguniang Panlungsod as the Legislative Body of the city shall enact ordinances, approve resolutions and appropriate fund for the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, xxx, as one of the corporate powers of the city xxx, shall: (i) "Review all ordinances approved by the Sangguniang Barangay and executive orders issued by the Punongbarangay to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Punongbarangay.";

WHEREAS, the City Budget Office after evaluation of Barangay Putatan's submitted 2022 budget, found the same to have complied with rules, regulations, and appropriate memoranda on budget preparation, recommended its adoption;

WHEREAS, the proposed expenditure program follows the development directions of the Barangay Development Plan as approved by the Barangay Assembly and is fully consistent with the approved barangay Annual Investment Program (AIP) for the Fiscal Year 2022;

WHEREAS, the sources of fund of Barangay Putatan as certified by the City Treasurer are as follows:

**WHEREAS**, in compliance with the mandatory requirements of the law, the following have been provided:

**WHEREAS**, all procurement of goods, supplies and materials, equipment and infrastructure/civil works shall be subject to the pertinent provision of R.A No.9184 (Government Procurement Reform Act) and its **Revised Implementing Rules and Regulations (IRR)**; and prior clearances from pertinent agencies as maybe appropriate /needed. In addition, all procurement shall be included to the duly approved Annual Procurement Plan;

**WHEREAS**, Barangay Budget shall be available exclusively for the specific purposes for which it has been appropriated and shall be spent solely for public purposes. Thus, no monies shall be paid out of Treasury except in pursuance of an Appropriation Ordinance or Law;

**NOW THEREFORE, BE IT ENACTED**, by the 9<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to approve the Barangay Budget for FY 2022 of Barangay Putatan, amounting to **One Hundred Thirty-Two Million Five Hundred Thousand Pesos (Php132,500,000.00)**.

**ENACTED**, by the 9<sup>th</sup> **Sangguniang Panlungsod of Muntinlupa** this 2<sup>nd</sup> day of **May 2022**, on its 147<sup>th</sup> Regular Session.
