AN ORDINANCE GRANTING FINANCIAL ASSISTANCE TO THE SEVENTY-SIX (76) FAMILY AFFECTED BY CONFLAGRATION ON MAY 8, 2022 AT SITIO APLAYA, PUROK 6, BARANGAY SUCAT, MUNTINLUPA CITY AMOUNTING TO FOUR HUNDRED NINETY-TWO THOUSAND PESOS (PHP492,000.00)

WHEREAS, Section 16 of the Local Government Code of 1991 states that "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessarily appropriate, incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare":

(I)(iv) adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood xxx";

WHEREAS, on May 8, 2022 at 1:27 a.m., thirty-two (32) structures, consisting of seventy-six (76) families, were gutted by fire at Sitio Aplaya, Purok 6, Barangay Sucat, Muntinlupa City;

WHEREAS, on May 8, 2022 the Social Service Department (SSD) submitted final report to the City Council of the affected families to wit:

1. Thirty-Two (32) structures;
2. Seventy-Six (76) families;
3. Two Hundred Seventy (271) individuals;

WHEREAS, the **Social Service Department (SSD)** of the City of Muntinlupa is given the authority to determine the homeowners, renters and sharers, in coordination with the **Barangay Chairman of Sucat, Muntinlupa City**;

WHEREAS, the amount of **Four Hundred Ninety-Two Pesos (Php492,000.00)** was given to affected families to wit:
