AN ORDINANCE NAMING THE STREETS OF THE NATIONAL HOUSING AUTHORITY (NHA)-SOUTHVILLE 3 AT BARANGAY POBLACION, MUNTINLUPA CITY

WHEREAS, Section 13, paragraph b (2) of the Local Government code of 1991 authorizes the sanggunian of highly-urbanized cities, in consultation with the National Historical Commission of the Philippines (NHCP), to change name of city roads, avenues, boulevards, thoroughfare and bridges;

WHEREAS, the Revised Guidelines on the Naming and Renaming of streets issued by the National Historical Commission states that public places under the of the local government unit may be named and renamed subject to the guidelines setforth therein;

WHEREAS, the National Housing Authority (NHA)- Southville 3 located at Barangay Poblacion, Muntinlupa City, is a government housing project established sometime in the year 2001 consisting of more or less fifty (50) hectares with thirty-nine (39) unnamed streets;

WHEREAS, the thirty-nine (39) unnamed streets are known only as phases and avenues which do not accurately locate the addressee;

WHEREAS, a Technical Working Group (TWG) for the naming of streets at the NHA-Southville 3 Housing Project, comprised of representatives of the City Engineering Department, City Planning Office, City Zoning Administration Office, NHA, Southville 3 Homeowners Association and the Tourism, Culture and the Arts Department, upon considerations of the prevailing guidelines set by the NHCP, and the Department of Highways and Public Works' (DPWH) classification of roads, forwarded its proposed names for approval of the Sanggunian pursuant to law;

SECTION 2. Names of Avenue, Street, Secondary Road and Phase. The following avenues, streets, secondary roads and phases at the NHA-Southville 3 shall be named as follows:

SECTION 3. Implementing Rules and Regulations. The TWG for the naming of streets shall formulate the guidelines for the efficient implementation of this ordinance. The TWG, in partnership/ cooperation with concerned departments, national agencies, public utilities group shall likewise promote a massive information dissemination of this ordinance.

SECTION 4. Publication - This Ordinance shall be published pursuant to the requirements of the Local Government Code and shall be posted by the Public Information Office (PIO) in the Official Website of the City Government of Muntinlupa and in all available social media platforms.

ENACTED, by the 9th Sangguniang Panlungsod this 20th day of June 2022, on its 153rd Regular Session.
