WHEREAS, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the project construction JRF Pavillion located at Parkhomes Subdivision, Barangay Putatan, Muntinlupa City in the newspaper of general circulation and likewise posted at the Government Electronic Procurement System (GEPS) City's Website and conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, there is one (1) Bidder who submitted Bid on **March 15, 2022** and Passed the Preliminary Examination of Bid at the City Administration Conference Room, 2nd Floor City Hall Main Building, National Road, Barangay Putatan, Muntinlupa;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, **Ayana Construction Corporation's** bid has been responsive to **Approved Budget for the Contract (ABC)** amounting to Thirteen Million Three Hundred Forty-One Thousand Eleven Pesos and 14/100 (**Php13,341,011.14**);

WHEREAS, the project was awarded to **Ayana Construction Corporation**, who being the lowest bidder for the project **JRF Pavillion located at Parkhomes Subdivision, Barangay Putatan, Muntinlupa City**;
