WHEREAS, all procurement of goods, supplies and materials, equipment and infrastructure/civil works shall be subject to the pertinent provision of R.A No.9184 (Government Procurement Reform Act) and its Revise IRR; and prior clearances from pertinent agencies as maybe appropriate /needed. In addition, all procurement shall be included to the duly approved Annual Procurement Plan;

WHEREAS, it shall be available exclusively for the specific purposes for which they have been appropriated and shall be spent solely for public purposes. Thus, no monies shall be paid out of SK Treasury except in pursuance of an appropriation ordinance or law;

NOW THEREFORE, BE IT ENACTED, by the 9th Sangguniang Panlungsod of Muntinlupa, to approved the SK Budget for FY 2021 of **Barangay Ayala-Alabang**, amounting to **Seven Million Nine Hundred Three Thousand Eight Hundred Eighty-Six Pesos (Php7,903,886.00)**.
