AN ORDINANCE GRANTING FINANCIAL ASSISTANCE TO THE FIVE (5) FAMILIES AFFECTED BY CONFLAGRATION ON FEBRUARY 28, 2022 AT NO. 2 A. YUCHENGCO DRIVE, PACIFIC MALAYAN VILLAGE AND NUMBERS 10, 11, 12 BARANGAY CUPANG, TOWN HOMES, MUNTINLUPA CITY AMOUNTING TO ONE HUNDRED FORTY THOUSAND PESOS (PHP140,000.00)

WHEREAS, Section 16 of the Local Government Code of 1991 states that "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessarily appropriate, incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare":

(I)(iv) adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood xxx";


WHEREAS, on February 28, 200 at 3:35 p.m., four (4) structures, consisting of five (5) families, were gutted by fire at No. 2 A. Yuchengco Drive, Pacific Malayan Village and Numbers 10, 11, 12 Kalipayan Town Homes, Barangay Cupang, Muntinlupa City;

WHEREAS, on March 3, 2022 the Social Service Department (SSD) submitted final report to the City Council of the affected families to wit:

- 1. Four (4) structures;
- 2. Five (5) families;
- 3. Thirteen (13) individuals;

WHEREAS, the owners of the house, renter/sharers, were rendered homeless by reason of the said conflagration;
