AN ORDINANCE REINSTATING/ REVERSING TO ONE HUNDRED PERCENT (100%)
THE ALLOWANCES GRANTED TO NATIONAL GOVERNMENT OFFICIALS AND
EMPLOYEES STATIONED IN OR ASSIGNED TO MUNTINLUPA CITY

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991 (LGC) states that, *“Every Local Government Unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;”*

WHEREAS, Section 458, paragraph XI, of the LGC provides that, *“the Sangguniang, when the finances of the city government allow, provide for additional allowances and other benefits to Judges, Prosecutors, Public Elementary and High School Teachers, and other Government Officials stationed in or assign to the City;”*

WHEREAS, the City Government of Muntinlupa, recognizing the importance of the services of national agencies in the over-all operations in the LGU, enacted various ordinances bestowing financial favors to officials and employees stationed/ assigned in the city, to wit:

- a. Ordinance 18-140- An Ordinance Granting Monthly Allowance/Honorarium to National Government Personnel Stationed Or Assigned InThe City Of Muntinlupa;
- b. Ordinance No. 18-158, “An ordinance granting allowance/honorarium to National Offices and Local Committees which amount shall be taken from the 2018 Executive Budget under the concerned offices;

- c. Ordinance No. 2018-228, entitled, "An Ordinance Amending Provisions In Ordinance No. 18-158 entitled, "**An ordinance granting allowance/honorarium to National Offices and Local Committees which amount shall be taken from the 2018 Executive Budget under the concerned offices.**;"

WHEREAS, by virtue of Ordinance 2020-105, the Sanggunian reduced the allowances granted to the complement of national agencies in response to the need to use the fund for Covid-19 responses, and was consequently adjusted by Ordinance 2021-213;

WHEREAS, on February 9, 2022, the LFC, through its Resolution No.1, Series of 2022, recommended to revert back the amount of allowances or honorarium to 100% citing the improvement in the cash position or finances of the City;

NOW, THEREFORE BE IT ORDAINED, by the 9th Sangguniang Panlungsod of Muntinlupa, the following:

SECTION 1. Reversion of Allowance. The amount of allowance being granted under Ordinance No, 18-140 or An Ordinance Granting Monthly Allowance/Honorarium To National Government Personnel Stationed Or Assigned In The City Of Muntinlupa shall be applied and paid to the national agencies complement;

SECTION 2. Exemption. The Chief Probation and Parole Officer whose allowance was increased under Ordinance 2021-293 shall be exempted from the provision of this ordinance

SECTION 3. Effectivity. This Ordinance shall take effect upon its approval.

ENACTED, by the 9th Sangguniang Panlungsod of Muntinlupa this 14th day of September 2022, on its 136th Regular Session.




