INVITATION TO BID FOR THE CONSTRUCTION OF FOOD & NON-FOOD ROOMS AT MCTI ANNEX SV3 POBLACION, MUNTINLUPA CITY

- 1. The City Government of Muntinlupa, through the duly approved 2022 Supplemental Budget #4-INFRA Fund & 2022 Executive Budget-GAD Fund intends to apply the sum of Two Million Nine Hundred Ninety One Thousand Five Hundred Ten Pesos & 20/100 (P2,991,510.20) being the Approved Budget for the Contract (ABC) to payments under the contract for Construction of Food & Non-Food Rooms at MCTI Annex SV3 Poblacion, Muntinlupa City. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The City Government of Muntinlupa now invites bids for the above Procurement Project. Completion of the Works is required within Ninety (90) calendar days from receipt of the Notice to Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- Bidding will be conducted through open competitive bidding procedures using nondiscretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from BAC Secretariat and inspect the Bidding Documents at the address given below from 8:00 o'clock am to 5:00 o'clock pm.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on November 29, 2022 from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (P5,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, by facsimile or through electronic means.
- 6. The City Government of Muntinlupa will hold a Pre-Bid Conference **on December 6, 2022** 8:30 a.m. at the Audio Visual Room, 2/F City Hall Main Building, National Road, Putatan, Muntinlupa City which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before **December 20, 2022,** 9:00 a.m. Late bids shall not be accepted.
