

Contract Agreement

WHEREAS, the Entity is desirous that the Contractor execute Construction of Perimeter Fence & Canopy Truss Extension at Mutual Homes 1 & 2 Covered Court Putatan, Muntinlupa City/8632604 (hereinafter called "the Works") and the Entity has accepted the Bid for Three Million One Hundred Fourteen Thousand Seven Hundred Four Pesos (P3,114,704.00) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that additional contract</u> documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.




