**INVITATION TO BID FOR THE REPAIR & MAINTENANCE OF
VARIOUS SCHOOL BUILDINGS OF ECED**

1. The City Government of Muntinlupa, through the duly approved 2022 Local School Board Budget, intends to apply the sum of **Six Million Five Hundred Eighty Six Thousand Five Hundred Sixty Two pesos and 8/100 (P6,586,562.08)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Repair & Maintenance of Various School Buildings of ECED/200-2212-00057**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The City Government of Muntinlupa now invites bids for the above Procurement Project. Completion of the Works is required within **One Hundred Twenty (120) calendar days from receipt of the Notice to Proceed**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from BAC Secretariat and inspect the Bidding Documents at the address given below from **8:00 o'clock am to 5:00 o'clock pm**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **January 6, 2023** from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Ten Thousand Pesos (P10,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, by facsimile or through electronic means.
6. The City Government of Muntinlupa will hold a Pre-Bid Conference on **January 13, 2023** 8:30 a.m. at the Audio Visual Room, 2/F City Hall Main Building, National Road, Putatan, Muntinlupa City which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before **January 26, 2023, 8:00 a.m.** Late bids shall not be accepted.
