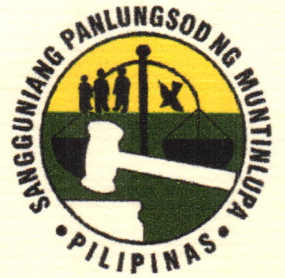

ORDINANCE NO. 19-020

AN ORDINANCE GRANTING FINANCIAL ASSISTANCE AMOUNTING TO ONE MILLION PESOS (PHP1,000,000.00) TO THE MUNICIPALITY OF KIDAPAWAN CITY, PROVINCE OF NORTH COTABATO WHICH WAS DEVASTATED BY A SERIES OF EARTHQUAKES LAST OCTOBER 2019 WHICH AMOUNT SHALL BE TAKEN FROM THE 2019 EXECUTIVE BUDGET UNDER THE 30% QUICK RESPONSE FUND (QRF) OF MUNTINLUPA CITY DISASTER RISK REDUCTION AND MANAGEMENT FUND (MCDRRMF).

WHEREAS, Rule 18, Section 2, of the Implementing Rules and Regulations (IRR) of Republic Act No. 10121, provides for a Quick Response Fund (QRF) intended for, "relief and recovery programs in order that the situation and living conditions of people in communities or areas stricken by disaster calamities, epidemic, or complex emergencies, may be normalized as quickly as possible";

WHEREAS, Republic Act No. 10121, otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010 particularly Section 21 thereof, provides that, "the Local Disaster Risk Reduction and Management Fund may be used to support other affected local government units";

WHEREAS, Section 5(b.2) of the Rules and Regulations Implementing Republic Act No. 8185 or "An Act amending Section 324(d) of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates that, "a portion of Calamity Fund maybe authorized to be used by the Local Government Unit concerned to provide financial assistance to other Local Government Units (LGUs)";

WHEREAS, the Municipality of Kidapawan City, Province of North Cotabato, have been hit by 6.3 Magnitude earth quake and the City Government of Muntinlupa aims to extend financial and relief assistance to the affected Municipality of the aforesaid Province;

WHEREAS, *Mr. Erwin O. Alfonso*, Head of **Muntinlupa City Disaster Risk Reduction and Management Office (MCDRRMO)** wrote a letter to **City Mayor Atty. Jaime R. Fresnedi** requesting to provide and extend financial assistance to aid in the rehabilitation and recovery operation in the area;

WHEREAS, there is an available fund from the Local Disaster Risk Management Fund (LDRRMF) of the City Government of Muntinlupa to extend and provide assistance to **Municipality of Kidapawan City, Province of North Cotabato**;

WHEREAS, the **National Disaster Risk Reduction and Management Council (NDRRMC)** has reported the situation of **Kidapawan City, Province of North Cotabato**, the casualty and injured brought by the **series of Earthquakes** in the said Province;

NOW THEREFORE, BE IT ENACTED, AS IT IS HEREBY ENACTED, by 9<sup>th</sup> Sangguniang Panlungsod of Muntinlupa to grant financial assistance amounting to **One Million Pesos (Php1,000,000.00)** to the **Municipality of Kidapawan City, Province of North Cotabato**, which was devastated by a series of **Earthquakes** last **October 2019** which amount shall be taken from the **2019 Executive Budget** under the **30% Quick Response Fund (QRF)** of **Muntinlupa City Disaster Risk Reduction and Management Fund (MCDRRMF)**.

ENACTED, by 9<sup>th</sup> Sangguniang Panlungsod of Muntinlupa this 4<sup>th</sup> day of **November 2019**, on its 19<sup>th</sup> Regular Session.
