WHEREAS, Section 5(b.2) of the Rules and Regulations !mplementing Republic Act No. 8185 or "An Act amending Section 324(d) of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates that, "a portion of Calamity Fund may be authorized to be used by the Local Government Unit concerned to provide financial assistance to other Local Government Units (LGUs)";

WHEREAS, the Municipality of Magsaysay, Province of Davao Del Sur have been hit by 6.3 Magnitude earth quake and the City Government of Muntinlupa aims to extend financial and relief assistance to the affected Municipality of the aforesaid

WHEREAS, Mr. Erwin O. Alfonso, Head of Muntinlupa City Disaster Risk Reduction and Management Office (MCDRRMO) wrote a letter to City Mayor Atty. Jaime R. Fresnedi requesting to provide and extend financial assistance to aid in the rehabilitation and recovery operations in the area;

WHEREAS, there is an available fund from the Local Disaster Risk Management Fund (LDRRMF) of the City Government of Muntinlupa to extend and provide assistance to Magsaysay, Province Of Davao Del Sur.

WHEREAS, the National Disaster Risk Reduction and Management Council (NDRRMC) has reported the situation of Magsaysay, Province of Davao Del Sur, the casualty and injured brought by the series of Earthquakes in the said Province:

NOW THEREFORE, BE IT ENACTED, AS IT IS HEREBY ENACTED, by 9th Sangguniang Panlungsod of Muntinlupa to grant financial assistance amounting to One Million Pesos (Php1,000,000.00) to the Municipality of Magsaysay, Province of Davao Del Sur, which was devastated by a series of Earthquakes last October 2019 which amount shall be taken from the 2019 Executive Budget under the 30% Quick Response Fund (QRF) of Muntinlupa City Disaster Risk Reduction and Management Fund (MCDRRMF).

ENACTED, by 9th Sangguniang Panlungsod of Muntinlupa this 4th day of November 2019, on its 19th Regular Session.
