## **RESOLUTION NO. 19-076**

A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH JADOMINIA CONSTRUCTION AND SUPPLIES FOR THE PROJECT ASPHALT OVERLAY LOCATED AT RMT INDUSTRIAL COMPLEX, BARANGAY TUNASAN, MUNTINLUPA CITY IN THE AMOUNT OF ONE MILLION FIVE HUNDRED THIRTY SIX THOUSAND NINE HUNDRED EIGHTY PESOS (PHP1,536,980.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2019 EXECUTIVE BUDGET UNDER 20% COMMUNITY DEVELOPMENT FUND - INFRASTRUCTURE FUND.
