AN ORDINANCE GRANTING FINANCIAL ASSISTANCE AMOUNTING TO ONE MILLION PESOS (PHP1,000,000.00) EACH TO THE LOCAL GOVERNMENTS OF SAN NICOLAS AND LEMERY, PROVINCE OF BATANGAS, WHICH WERE DEVASTATED BY THE TAAL VOLCANIC ERUPTION LAST JANUARY 12, 2020 WHICH AMOUNT SHALL BE TAKEN FROM THE 2020 EXECUTIVE BUDGET UNDER THE 30% QUICK RESPONSE FUND (QRF) OF MUNTINLUPA CITY DISASTER RISK REDUCTION AND MANAGEMENT FUND (MCDRRMF).

WHEREAS, Rule 18, Section 2, of the Implementing Rules and Regulations (IRR) of Republic Act No. 10121, provides for a Quick Response Fund (QRF) intended for "relief and recovery programs in order that the situation and living conditions of people in communities or areas stricken by disaster calamities, epidemic, or complex emergencies, may be normalized as quickly as possible";

WHEREAS, Republic Act No. 10121, otherwise known as the Philippine Disaster Risk Reduction and Management Act 2010 particularly Section 21 thereof, provides that "the Local Disaster Risk Reduction and Management Fund may be used to support other affected local government units";

WHEREAS, Section 5(b.2) of the Rules and Regulations Implementing Republic Act No. 8185 or "An Act amending Section 324 (d) of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates that, "a portion of Calamity Fund may be authorized to be used by the Local Government Unit concerned to provide financial assistance to other Local Government Units (LGUs)";

WHEREAS, on January 12, 2020, the Taal Volcanic Eruption which is a large complex volcano, underwent volcanic eruption spewing ash and volcanic debris in neighboring local government units as well as parts of National Capital Region (NCR);

WHEREAS, on its first day of volcanic activity the PHILVOCS reported that the Philippine Seismic Networks has reported a total of one hundred forty-four (144) volcanic earthquakes in the Taal Region which are prompted PHILVOCS to raise alarm level to four (4) (hazardous eruption imminent);

WHEREAS, the Local Governments of San Nicolas and Lemery in the Province of Batangas were recommended by the Muntinlupa City Disaster Risk Reduction Management Office (MCDRRMO) to be beneficiaries of a financial grant due to its proximity to Taal Volcano and based in the report of the PHILVOCS;

WHEREAS, there is an available fund from the Local Disaster Risk Reduction Management Fund (LDRRMF) of the City Government of Muntinlupa which may be used to extend and provide assistance to the Local Governments of San Nicolas and Lemery, Province of Batangas;

NOW, THEREFORE, BE IT ENACTED, AS IT IS HEREBY ENACTED, by 9<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to grant financial assistance amounting to One Million Pesos (Php1,000,000.00) each to the Local Governments of San Nicolas and Lemery, Province of Batangas, which were devastated by the *Taal Volcanic Eruption* last January 12, 2020 which amount shall be taken from the 2020 which amount shall be taken from the 2020 which amount shall be taken from the 2020 Executive Budget under the 30% Quick Response Fund (QRF) of Muntinlupa City Disaster Risk Reduction and Management Fund (MCDRRMF).
