WHEREAS, Section 16 of the Local Government Code of 1991 (R.A. No. 7160) further provides that, "every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental to its efficient and effective governance, and those which are essential to the promotion of general welfare";

WHEREAS, the City Council enacted Ordinance No. 07-132 as amended by Ordinance No. 09-083, otherwise known as the Market Code of Muntinlupa City;

WHEREAS, the proposed adjusted Market Fees to be collected is for the reconfigured temporary Market Stalls in view of the on-going new construction of the Muntinlupa City Market in Barangay Alabang;

WHEREAS, The Muntinlupa Public Market is currently undergoing a major renovation and modernization of its building and facilities to comply with the requirements of the National Grid Corporation of the Philippines for power lines traversing above the public market;

WHEREAS, the MCPM will improve its competitiveness and address the need a well-designed, properly-zone and highly accessible public market place.

NOW THEREFORE, BE IT ENACTED, by the 9th Sangguniang Panlungsod of Muntinlupa in Session assembled that:

SECTION 1. Title – This ordinance shall be known as the Adjusted Fees for Temporary Market Stalls at Muntinlupa City Public Market.

SECTION 2. The Technical Working Group of MCPM decided to give priority of the temporary stalls to the residents of Muntinlupa only.

SECTION 3. The said adjusted fees for Market Stalls shall be based on the square meter per stall.

SECTION 4. The adjusted Market Fees by virtue of Market Code of Muntinlupa City are as follows:

SECTION 5. Separability Clause. If, for any reason or reasons, any part/s or provision/s of this Ordinance shall be held to be unconstitutional or invalid, other part/s or provision/s hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 6. Repealing Clause. All previous ordinances inconsistent with this Ordinance shall be deemed repealed or modified accordingly.




SECTION 7. Effectivity Clause. This Ordinance shall be effective immediately upon its approval.


