WHEREAS, both Article III, Section 8(d) of the City Charter of Muntinlupa (Republic Act 7926) and Section 454(d) of the (Republic Act 7160), otherwise known as the Local Government Code of 1991 provide that, "unless otherwise provided herein, heads of departments and offices shall be appointed by the City Mayor with the concurrence of the Majority of all the Sangguniang Panlungsod members, subject to civil service law, rules and regulations. The Sangguniang Panlungsod shall act on the appointment within fifteen (15) days from the date of its submission, otherwise the same shall be deemed confirmed";

WHEREAS, the mandate of the Committee on Personnel Administration under Rule VIII (s) of the Internal Rules of Procedure for the 9th Sangguniang Panlungsod of Muntinlupa to confirm all appointments made by the Honorable City Mayor is derived from Article III, Section 8(d) of Republic Act 7926, otherwise known as the "City Charter of Muntinlupa" which provides as follows:

"Unless otherwise provided herein, all appointed city officials of the City shall be appointed by the City Mayor with the concurrence of the majority of all the Sangguniang Panlungsod Members, subject to Civil Service Law, Rules and Regulations. The Sangguniang Panlungsod shall act on the appointment within fifteen (15) days from the date of its submission, otherwise the same shall be deemed confirmed."

WHEREAS, the Hon. City Mayor Atty. Jaime R. Fresnedi, as the appointing authority, has recommended the appointment of Atty. Genalyn Calixto Estrera as City Government Department Head II at the Office of the City Mayor-Propor of the City Government of Muntinlupa and has submitted the same for the confirmation by the City Council;
