WHEREAS, on July 8, 1996 the Sangguniang Panlungsod enacted Ordinance No. 96-81, entitled, *"An ordinance exempting all legitimate cooperatives, registered and operating within the City of Muntinlupa from all taxes, fees, and any dues imposed by the City Government"*;

WHEREAS, Section 34 of Republic Act No. 7160, otherwise Known as the Local Government Code of 1991, provides that, *"Local Government units shall promote the Establishment and operations of the People's and Non- Government organizations to become active partners in their pursuit of local autonomy"*,

WHEREAS, Section 11 of Ordinance No. 05-040, *"any organization and its officers who are found to have used its accreditation for illegal purposes shall be prohibited from seeking accreditation and shall be blacklisted. Any organization violating the terms and conditions of its accreditation shall not be renewed and shall not enjoy privileges provided under this ordinance"*,

WHEREAS, Section 7 of Ordinance No. 05-040, states that, *"the organization duly accredited by the Sangguniang Panlungsod may be entitled to assistance, financial or otherwise for its economic, socially-oriented, environmental, environmental and cultural projects to be implemented within the territorial jurisdiction of Muntinlupa City"*.

WHEREAS, Ordinance No. 05-040 as amended by the City Ordinance No. 06-093, states that, *"the organization duly accredited by the Sangguniang Panlungsod shall enjoy privileges of an accredited organization for three (3) years from the time of the Chief Executive signs the Resolution for accreditation. Provided that:*

- I. The organization must still submit on an annual basis a copy of its annual report to the **Securities and Exchange Commission (SEC)** or a copy of the annual report to the **Housing and Land Use Regulatory Board (HLURB)**. Or **Cooperative Development Authority (CDA)** or whatever national agency which requires submission of annual report.
- II. The Organization must still submit the annual or biennial report as the case may be, of the results of the elections of its new set of officers or Board of Directors.
- III. The organization must still submit an annual financial report and annual accomplishment report as required by the ordinance.

WHEREAS, the **South Greenheights Village Multi-Purpose Cooperative**, complied with all the requirements required by the Ordinance No. 05-040 as amended by Ordinance No. 06-093;

WHEREAS, Section 6 of Ordinance No. 05-040, states that, "**this accreditation is renewable two (2) months prior the expiration of the accreditation**";

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod of Muntinlupa, to grant the accreditation to **South Greenheights Village Multi-Purpose Cooperative** located at **#8 Kalanchoe Street, South Greenheights Village, Barangay Putatan, Muntinlupa City**.

RESOLVED FURTHER, that copy of this resolution, shall give to aforementioned organization for their records and legal purposes.
