A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH AYANA CONSTRUCTION CORPORATION FOR THE PROJECT CONSTRUCTION OF DRAINAGE SYSTEM LOCATED AT BUENDIA ST., BARANGAY TUNASAN, MUNTINLUPA CITY IN THE AMOUNT OF SEVEN MILLION EIGHT HUNDRED NINETEEN THOUSAND FIVE HUNDRED ONE THOUSAND PESOS AND 62/100 (PHP7,819,501.62) WHICH AMOUNT SHALL BE TAKEN FROM 2019 SUPPLEMENTAL BUDGET UNDER THE 20% COMMUNITY DEVELOPMENT FUND (CDF).

WHEREAS, the City Government of Muntinlupa advertisement advertised the invitation to apply for eligibility and to bid for the project ***construction drainage system located at Buendia St., Barangay Tunasan, Muntinlupa City*** in the newspaper of general circulation likewise posted at the Government Electronic Procurement System (GEPS) and City's Website and the same conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisement, two (2) bidders submitted letter of intent and application for eligibility and was found eligible on **November 5, 2019**;
