**WHEREAS**, the 1987 Constitution grants Local government units' local autonomy in its political, fiscal and territorial aspects and administration;

**WHEREAS**, in recognition of the Local government unit's autonomy, the basic law of the land likewise mandated the Local Government Unit's (LGU's) equitable share in the national revenue through its Internal Revenue Allotment basing on the population, land area and equal sharing;

**WHEREAS**, it is imperative therefore that the geographical boundary of any local government unit be determined and established not only for purposes of computation of the Internal Revenue Allotment but also to establish the political jurisdiction and restore the historical/ cultural significance for posterity;

**WHEREAS**, the City of Muntinlupa has been pursuing the accurate and precise boundary in contest of the discrepancy in the data emanating from the Land Management Bureau and those of the Department of Budget and Management where under the data of the latter, the land area of the City is 39.75 kilometers as against the 46.7 square kilometers data of the City Planning Office;

**WHEREAS**, the discrepancy of more or less Seven Square Kilometers divests the City of the precious resources and its disenfranchised constituents the administration of the basic services which they should be entitled;

**NOW THEREFOR, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by 9<sup>th</sup> Sangguniang Paniungsod of Muntinlupa, to create the **Task Force on Boundary Dispute** to determine the actual boundary of the City of Muntinlupa.
