A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH CSL CONSTRUCTION CORPORATION FOR THE PROJECT CONSTRUCTION OF RETAINING WALL, DRAINAGE OUTFALL, SUMP PIT & PAVEMENT (COMPLETION) LOCATED AT HARMONYVILLE, PUROK 3, BARANGAY CUPANG, MUNTINLUPA CITY IN THE AMOUNT OF FIVE MILLION TWO HUNDRED SIXTY THREE THOUSAND ONE HUNDRED SIXTY-SEVEN PESOS AND 42/100 (PHP5,263,167.42) WHICH AMOUNT SHALL BE TAKEN FROM 2019 SUPPLEMENTAL BUDGET UNDER 20% COMMUNITY DEVELOPMENT FUND (CDF).
