A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER CONSTRUCTION AGREEMENT WITH CSL CONSTRUCTION INTO A CORPORATION FOR THE PROJECT CONSTRUCTION OF RETAINING WALL. DRAINAGE OUTFALL, SUMP PIT & PAVEMENT (COMPLETION) LOCATED AT HARMONYVILLE, PUROK 3, BARANGAY CUPANG, MUNTINLUPA CITY IN THE AMOUNT OF FIVE MILLION TWO HUNDRED SIXTY THREE THOUSAND ONE HUNDRED SIXTY-SEVEN PESOS AND 42/100 (PHP5,263,167.42) WHICH AMOUNT SHALL BE TAKEN FROM 2019 SUPPLEMENTAL BUDGET UNDER 20% COMMUNITY DEVELOPMENT FUND (CDF).

WHEREAS, the City Government of Muntinlupa advertisement advertised the invitation to apply for eligibility and to bid for the project construction of retaining wall, drainage outfall, sump pit & pavement (completion) located at Harmonyville, Purok 3, Barangay Cupang, Muntinlupa City in the newspaper of general circulation likewise posted at the Government Electronic Procurement System (GEPS) and City's Website and the same conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisement, two (2) bidders submitted letter of intent and application for eligibility and was found eligible on November 26, 2019;

WHEREAS, one (1) Bidder who submitted their Bid on November 26, 2019 and bidder Passed the Preliminary Examination of Bid at the City Administration Conference Room, 2nd Floor City Hall Main Building, National Road, Barangay Putatan. Muntinlupa:

WHEARES, upon post-qualification or careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, CSL Construction Corporation's bid has been responsive to Approved Budget for the Contract (ABC) amounting to Five Million Two Hundred Seventy Thousand (Php5,270,284.16);

WHEREAS, the project was awarded to CSL Construction Corporation who being the lowest bidder for the project construction of retaining wall, drainage outfall, sump pit & pavement (completion) located at Harmonyville, Purok 3, Barangay Cupang, Muntinlupa City;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod, to authorize the City Mayor Hon. Atty. Jaime R. Fresnedi, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with CSL Construction Corporation for the *project* construction of retaining wall, drainage outfall, sump pit & pavement (completion) located at Harmonyville, Purok 3, Barangay Cupang, Muntinlupa City in the amount of *Five Million Two Hundred Sixty Three Thousand One Hundred Sixty-Seven Pesos and 42/100 (Php5,263,167.42)* which amount shall be taken from 2019 Supplemental Budget under 20% Community Development Fund (CDF).
