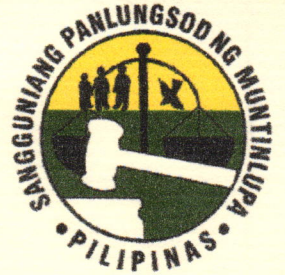

**WHEREAS**, Section 458 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, ***“empowers the Sanggunian to enact ordinances, approve resolutions and appropriate funds for the general welfare of the City and its inhabitants pursuant to Section 16 of Republic Act 7160”***;

**WHEREAS**, Food and Drug Administrative Order Circular No. 2014-025 sets the guidelines on the implementation of the new rules and regulation on the licensing of drug store/pharmacy/botica and similar outlets following Administrative Order 2014-0034 which mandated establishments involved in the sale and disposal of drugs to secure authority or License to Operate;

**WHEREAS**, the City Health has long been operating a centralized pharmacy where all the procured medicines are inventoried and distributed to different barangay health centers under its jurisdiction;

**WHEREAS**, Administrative Order No. 2016-0003 of the Department of Health requires compliance whether applicant is a **PUBLIC** or private entity hence, the Muntinlupa City Health Pharmacy which shall not operate as a business, is required to be secure a License to Operate;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the 9<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, **to authorizing the City Health Office (CHO) to operate a Muntinlupa City Pharmacy located at City Health Office (CHO), Laguerta, Barangay Tunasan, Muntinlupa City.**
