**WHEREAS**, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government Code of 1991, states that. ***“xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government unit without prior authorization by the Sangguniang concerned”;***

**WHEREAS**, the aforesaid endowment fund will tremendously benefit the indigent patient of Ospital ng Muntinlupa without monetary counter part of the City;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by 9<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to authorize the **Hon. City Mayor Atty. Jaime R. Fresnedi** to Enter into A **Memorandum of Agreement (MOA)** With The **Philippine Charity Sweepstakes Office (PCSO)** accepting the **Three Million Pesos (Php3,000,000.00)** Endowment Fund as **Medical Assistance Program** for and in Behalf of the Indigent Patients of the Ospital ng Muntinlupa.
