WHEREAS, Section 48, Article XVI of Republic Act No. 9184, provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement, which includes: Limited Source Bidding, Direct Contracting, Repeat Order, Shopping and Negotiated Procurement;

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, "the City Mayor shall represent the city in all its business transaction and sign in its behalf all bonds, contracts, and oblations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance";

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government Code of 1991, states that, "xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sangguniang concerned";

WHEREAS, on order to attain this objective and in view of the expiration of the previous printing and delivery of Lingkod Bayan contract, the City Government of Muntinlupa has caused the procurement of said contract through open and competitive bidding in accordance with the provisions of Republic Act No. 9184 or the Government Procurement Reform Act;
