FRESNEDI TO ENTER INTO AND SIGN IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA THE EXTENSION OF CONTRACT WITH SKYLIMIT PRINTING & ASCEND ENTERPRISES FOR PRINTING AND DELIVERY OF LINGKOD BAYAN FOR THE MONTHS OF JANUARY 01 TO MARCH 31, 2020, IN THE AMOUNT OF THREE HUNDRED FIFTY-EIGHT THOUSAND EIGHT HUNDRED PESOS (PHP358,800.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2020 EXECUTIVE BUDGET.

WHEREAS, Section 48, Article XVI of Republic Act No. 9184, provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement, which includes: Limited Source Bidding, Direct Contracting, Repeat Order, Shopping and Negotiated Procurement;

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, "the City Mayor shall represent the city in all its business transaction and sign in its behalf all bonds, contracts, and oblations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance",

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government Code of 1991, states that, "xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sangguniang concerned";

WHEREAS, on order to attain this objective and in view of the expiration of the previous printing and delivery of Lingkod Bayan contract, the City Government of Muntinlupa has caused the procurement of said contract through open and competitive bidding in accordance with the provisions of Republic Act No. 9184 or the Government Procurement Reform Act;

WHEREAS, Republic Act No. 9184 or the Government Procurement Act, created the **Government Procurement Policy Board (GPPB)** a body which is tasked to formulate, amend, whenever necessary, the *Implementing Rules and Regulations (IRR)* and the corresponding forms for Procurement;

WHEREAS, the **Government Procurement Policy Board (GPPB)** through its Resolution No. 03-2006 approved and adopted amendment to the **Government Procurement Policy Board (GPPB)** guidelines on Extension of Contracts which reads, "unless otherwise approved by the **Government Procurement Policy Board (GPPB)**";

WHEREAS, the *2019 Printing and Delivery of Lingkod Bayan* Newsletter contract of the Joint Venture of Sky Limit Printing & Ascend Enterprises with the City Government of Muntinlupa expired on **December 31, 2019**;

WHEREAS, the public bidding for the 2020 printing and delivery of Lingkod Bayan Newsletter contract has been substantially undertaken by the City Government with Bids and Awards Committee (BAC);

WHEREAS, in the meanwhile, there is a need to extend the existing printing and deliver of **Lingkod Bayan** Newsletter contract of the City Government for three (3) months as the new contract cannot yet be awarded within a month after expiration of the original contract;

WHEREAS, the **Extension of Contract** shall be effective for the interim period starting January 1, 2020 to March 31, 2020 the contract price is **Three Hundred Fifty-Eight Thousand Eight Hundred Pesos (PHP358,800.00)** to wit:

- a) *Regular Issue: Php 6.55 per copy*
- b) *Special Issue: Php10.25 per copy*

WHEREAS, there is a budget appropriated for printing and delivery of Lingkod Bayan amounting to **One Million Four Hundred Thirty-Five Thousand Two Hundred Pesos (Php1,435,200.00)** from the 2020 Executive Budget;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod Muntinlupa, to authorize the **City Mayor Atty. Jaime R. Fresnedi** to enter into and sign in behalf of the City Government of Muntinlupa the Contract of Extension of Service with **Skylimit Printing & Ascend Enterprises** for Printing and Delivery of Lingkod Bayan for the months of **January 01 to March 31, 2020** in the amount of **Three Hundred Fifty-Eight Thousand Eight Hundred Pesos (Php358,800.00)** which amount shall be taken from the 2020 Executive Budget.

RESOLVED FURTHER, that the approval of the herein Extension of Contract shall be subject to the submission of certification of availability of funds.






