A RESOLUTION AUTHORIZING THE CITY MAYOR ATTY. JAIME R. FRESNEDI TO ENTER AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE CITY GOVERNMENT OF MUNTINLUPA AND BEST SECURITY AGENCY FOR THE EXTENSION OF CONTRACT OF SECURITY SERVICES FOR THREE MONTHS FROM JANUARY 1 TO MARCH 31, 2020 IN THE AREA OF RESPONSIBILITY (OAR), MORE SPECIFICALLY: THE COLEGIO DE MUNTINLUPA, LOCATED IN POSADAS AVENUE, BARANGAY SUCAT, MUNTINLUPA CITY.

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, ***"the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances"***;

WHEREAS, Rule IX, Article 47 of the Rules and Regulation Implementing the Local Government of 1991, states that, ***"xxx no contract may be entered into by the Local Government Chief Executive in behalf of the Local Government Unit without prior authorization by the Sanggunian concerned"***;

WHEREAS, in order to attain this objective and in view of the expiration of the security services contract of the City Government of Muntinlupa has caused the procurement of said contract through open and competitive bidding in accordance with the provisions of Republic Act No. 9184 or the Government Procurement Reform Act;

WHEREAS, Republic Act No. 9184 or the Government Procurement Act, created the **Government Procurement Policy Board (GPPB)** a body which is tasked to formulate, amend, whenever necessary, the Implementing Rules and Regulations (IRR) and the corresponding forms for Procurement;

WHEREAS, the **Government Procurement Policy Board (GPPB)** through its Resolution No. 03-2006 approved and adopted amendment to the **Government Procurement Policy Board (GPPB)** guidelines on Extension of Contracts which reads, "unless otherwise approved by the **Government Procurement Policy Board (GPPB)**";

WHEREAS, the 2019 Security & Protection Services contract between the City Government of Muntinlupa and Best Security Agency has a duration of until December 31, 2019;

WHEREAS, a public bidding for the 2020 Security & Protection Services contract has been substantially undertaken by the Bids Awards Committee;

WHEREAS, in the meantime, there is a need to extend the 2020 Security & Services contract for least three (3) months as an emergency measure to maintain the status quo in the operations of the City Government and to avoid interruption of service;

WHEREAS, the **Extension of Contract** shall be effective for the interim period starting January 1, 2020 to March 31, 2020 the contract price is **Six Hundred Seventy-Nine Thousand One Hundred Eighteen Pesos and 60/100 (PHP679,118.60)** computed as follows:

One Year: Php2,716,474.42

Less: 2,037,355.81 (for 9 Months April 1 to December 31, 2020)

WHEREAS, there is available funds from 2020 Executive Budget;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod of Muntinlupa City, to authorize the City Mayor Atty. Jaime R. Fresnedi to enter and sign the Memorandum of Agreement (MOA) between the City Government of Muntinlupa and Best Security Agency for the Extension of Contract of Security Services in the Area of Responsibility (OAR), more specifically: The Colegio De Muntinlupa, Located in Posada Avenue, Barangay Sucat, Muntinlupa City amounting to **Six Hundred Seventy-Nine Thousand One Hundred Eighteen Pesos and 60/100 (Php679,118.60)** shall be taken from the 2020 Executive Budget.

APPROVED, by the 9th Sangguniang Panlungsod this 17th day of February 2020, on its 32nd Regular Session.
