FRESNEDI TO ENTER INTO AND SIGN IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA THE EXTENSION OF CONTRACT OF SERVICE WITH INTEGRATED WASTE MANAGEMENT INC., FOR THE COLLECTION, TREATMENT & DISPOSAL OF VARIOUS HOSPITAL WASTE FOR THE MONTHS OF JANUARY 01 TO MARCH 31, 2020, IN THE AMOUNT OF TWO HUNDRED THOUSAND PESOS (PHP200,000.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2020 EXECUTIVE BUDGET.

WHEREAS, Section 48, Article XVI of Republic Act No. 9184, provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement, which includes: Limited Source Bidding, Direct Contracting, Repeat Order, Shopping and Negotiated Procurement;

whereas, Section 53 of the same Article xvi, as implemented by Section 53, Rule X of the Revised IRR pf R.A. 9184, authorizes Negotiated Procurement as an alternative mode of procurement in the following cases:

WHEREAS, Republic Act No. 9184 or the Government Procurement Act, created the Government Procurement Policy Board (GPPB) a body which is tasked to formulate, amend, whenever necessary, the Implementing Rules and Regulations (IRR) and the corresponding forms for Procurement;

WHEREAS, the Government Procurement Policy Board (GPPB) through its Resolution No. 03-2006 approved and adopted amendment to the Government Procurement Policy Board (GPPB) guidelines on Extension of Contracts which reads, "unless otherwise approved by the Government Procurement Policy Board (GPPB) and upon written request by the procuring entity, contract extension shall be allowed only on a period month to month basis not to

exceed an aggregate period of six months.";

WHEREAS, the 2019 hospital waste collection, treatment and disposal services contract of Integrated Waste Management, Inc. (IWMI) with the city Government of Muntinlupa was awarded as a result of competitive bidding accordance with the provision of Republic Act No. 1984 or the Government Procurement Reform Act" and its Implementing Rules and Regulations (IRR), has duration until December 31, 2019;

WHEREAS, the public bidding for the 2020 Collection, Treatment & Disposal of various hospital waste has been substantially undertaken by the City Government, with the Bids and Awards Committee (BAC);

WHEREAS, there is a need to extend the existing healthcare waste collection. treatment and disposal services contract of the City Government with Integrated Waste Management, Inc., for three (3) months as the new contract cannot yet be awarded within a month after the expiration of the Original Contract;

WHEREAS, the extension of contract is merely an emergency measure to maintain status quo in the operation of the Ospital ng Muntinlupa and to avoid interruption of services;

WHEREAS, the contract price for the Collection, Treatment & Disposal of various hospital waste for one (1) year amounting to Eight Hundred Thousand Pesos (Php800,000.00) less the price for three (3) Months extension of the contract amounting to Two Hundred Thousand Pesos (Php200,000.00);

WHEREAS, the Extension of Contract shall be effective for the interim period starting January 1, 2020 to March 31, 2020;

WHEREAS, there is a budget appropriated for the Collection, Treatment & Disposal of various hospital waste for the year 2020;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod of Muntinlupa, to authorize the Hon. City Mayor Atty. Jaime R. Fresnedi to enter and sign in behalf of the City Government of Muntinlupa the Extension of Contract of Service with Integrated Waste Management Inc., (IWMI) for the Collection, Treatment & Disposal of Various Hospital Waste for the months of January 01 to March 31, 2020, in the amount of Two Hundred Thousand Pesos (Php200,000.00) which amount shall be taken from the 2020 Executive Budget,
