WHEREAS, Section 48, Article XVI of Republic Act No. 9184, provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement, which includes: Limited Source Bidding, Direct Contracting, Repeat Order, Shopping and Negotiated Procurement;

WHEREAS, Section 53 of the same Article xvi, as implemented by Section 53, Rule XVI of the Revised IRR pf R.A. 9184, authorizes Negotiated Procurement as an alternative mode of procurement in the following cases:

WHEREAS, Republic Act No. 9184 or the Government Procurement Act, created the Government Procurement Policy Board (GPPB) a body which is tasked to formulate, amend, whenever necessary, the Implementing Rules and Regulations (IRR) and the corresponding forms for Procurement;

WHEREAS, the Government Procurement Policy Board (GPPB) through its Resolution No. 03-2006 approved and adopted amendment to the Government Procurement Policy Board (GPPB) guidelines on Extension of Contracts which reads, "unless otherwise approved by the Government Procurement Policy Board (GPPB) and upon written request by the procuring entity, contract extension shall be allowed only on a period month to month basis not to exceed an aggregate period of six months.";

WHEREAS, the contract for the supply and delivery of laundry services at the Ospital ng Muntinlupa (OSMUN) with Mahalimuyak Laundry Corporation expired on December 31, 2019;

WHEREAS, the public bidding for the City Government contract for supply and delivery of laundry services for 2020 was conducted by the BAC and remains in the process until the start of the calendar year January 2020;

WHEREAS, it has been recommended by the Bids and Awards Committee (BAC) for the City Government to enter into an Extension of the Contract for Supply and delivery of laundry services with Mahalimuyak Laundry Corporation under the previous contract price, prior to the award of the new contract, subject to authority from and by appropriate resolution of the City Council;

WHEREAS, the Extension of Contract shall be effective for the interim period starting January 1, 2020 to March 31, 2020;

WHEREAS, the contract price for January 1 to March 31, 2019 is Six Hundred Eighteen Thousand Seven Hundred Pesos (Php618,750.00) based on the old contract price:

WHEREAS, there is a budget appropriate for supply and delivery of laundry services amounting to Two Million Four Hundred Seventy-Five Thousand Five Hundred Pesos (Php2,475,000.00) for the year 2020;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod of Muntinlupa, to authorize the Hon. City Mayor Atty. Jaime R. Fresnedi to enter and sign in behalf of the City Government of Muntinlupa the Extension of Contract with Mahalimuyak Laundry Corporation for supply and delivery of laundry services for the month of January 01 to March 31, 2020, in the amount of Six Hundred Eighteen Thousand Seven Hundred Pesos (Php618,750.00) which amount shall be taken from the 2020 Executive Budget.
