FRESNEDI TO ENTER INTO AND SIGN IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA THE EXTENSION OF CONTRACT OF SERVICE WITH LITA INES CANTEEN FOR SUPPLY AND DELIVERY OF DIETARY SERVICES FOR THE MONTHS OF JANUARY 01 TO MARCH 31, 2020, IN THE AMOUNT OF THREE MILLION NINETY-FOUR THOUSAND ONE HUNDRED FORTY-THREE PESOS AND 75/100 (PHP3, 094,143.75) WHICH AMOUNT SHALL BE TAKEN FROM THE 2020 EXECUTIVE BUDGET.

WHEREAS, Section 48, Article XVI of Republic Act No. 9184, provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement, which includes: Limited Source Bidding, Direct Contracting, Repeat Order, Shopping and Negotiated Procurement;

WHEREAS, in order to attain this objective and in view of the expiration of the previous **Supply and Delivery of Dietary Services contract**, the City Government of Muntinlupa has caused the procurement of said contract through open and competitive bidding in accordance with the provisions of Republic Act No. 9184 or the Government Procurement Reform Act;

WHEREAS, Republic Act No. 9184 or the Government Procurement Act, created the **Government Procurement Policy Board (GPPB)** a body which is tasked to formulate, amend, whenever necessary, the **Implementing Rules and Regulations (IRR)** and the corresponding forms for Procurement;

WHEREAS, the **Government Procurement Policy Board (GPPB)** through its Resolution No. 03-2006 approved and adopted amendment to the **Government Procurement Policy Board (GPPB)** guidelines on Extension of Contracts which reads, "**unless otherwise approved by the Government Procurement Policy Board (GPPB) and upon written request by the procuring entity, contract extension shall be allowed only on a period month to month basis not to exceed an aggregate period of six months.**";

WHEREAS, the contract price for one (1) year amounting to **Twelve Million Three Hundred Seventy-Six Thousand Five Hundred Seventy-Five Pesos (Php12,376,575.00)** less the price for three (3) months extension of contract amounting to **Three Million Ninety-Four Thousand One Hundred Forty-Three Pesos and 75/100 (Php3,094,143.75);**

WHEREAS, the contract for the supply and delivery of dietary services at the Ospital ng Muntinlupa (OSMUN) with **Lita Ines Canteen** expired on **December 31, 2019;**

WHEREAS, it has been recommended by the Bids and Awards Committee (BAC) for the City Government to enter into an Extension of the Contract for Supply and delivery of dietary services with **Lita Ines Canteen;**

WHEREAS, the Extension of Contract shall be effective for the interim period starting **January 1, 2020 to March 31, 2020;**

WHEREAS, the contract price for **January 1 to March 31, 2020** is **Three Million Ninety-Four Thousand One Hundred Forty-Three Pesos and 75/100 (PHP3,094,143.75)** computed as follows: contracts/bid price for 1 year Twelve Million Three Hundred Seventy-Six Thousand Five Hundred Seventy-Five Pesos (Php12,376,575.00) less contract/bid price for 9 months corresponding to April to December 2020 of Php9,282,431.25;

WHEREAS, there is a budget appropriate for supply and delivery of dietary services from the 2020 Executive Budget;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod of Muntinlupa, to authorize the Hon. City Mayor Atty. Jaime R. Fresnedi to enter and sign in behalf of the City Government of Muntinlupa the Extension of Contract with **Lita Ines Canteen** for supply and delivery of dietary services for the months of **January 01 to March 31, 2020**, in the amount of **Three Million Ninety-Four Thousand One Hundred Forty-Three Pesos and 75/100 (Php3,094,143.75)** which amount shall be taken from the 2020 Executive Budget.
