FRESNEDI TO ENTER AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) IN BEHALF OF OSPITAL NG MUNTINLUPA (OSMUN) FOR EXTENSION OF CONTRACT SERVICE WITH POLOVENT ENTERPRISES, FOR THE SERVICE OF MECHANICAL VENTILATOR RENTAL SERVICES NEEDED BY PATIENTS IN SEVERE RESPIRATORY DISTRESS FOR THE MONTHS OF JANUARY 1 TO MARCH 31, 2020 IN THE AMOUNT OF (PHP498,750.00) AMOUNT SHALL BE TAKEN FROM 2020 EXECUTIVE BUDGET.

WHEREAS, Article 86 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, **"the City Mayor shall represent the city in all its business transaction and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances"**;

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government Code of 1991, states that, **"xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sangguniang concerned"**;

WHEREAS, Republic Act No. 9184 or the Government Procurement Act, created the **Government Procurement Policy Board (GPPB) a body which is tasked to formulate, amend, whenever necessary, the Implementing Rules and Regulations (IRR) and the corresponding forms for Procurement**;

WHEREAS, the **Government Procurement Policy Board (GPPB)** through its Resolution No. 03-2006 approved and adopted amendment to the **Government Procurement Policy Board (GPPB)** guidelines on Extension of Contracts which reads, **"unless otherwise approved by the Government Procurement Policy Board (GPPB) and upon written request by the procuring entity, contract extension shall be allowed only on a period month to month basis not to exceed an aggregate period of six months."**;

**WHEREAS**, provided the conditions for contract extension have been met under the said guidelines, procuring entities are allowed to extend its existing contracts for general services on a periodic month-to-month basis but not to exceed two (2) months unless otherwise approved by the Government Procurement Policy Board (GPPB);

**WHEREAS**, the Ospital ng Muntinlupa requested to the Sangguniang Panlungsod an authority to enter into a contract with **Polovent Enterprises** the provider of **mechanical ventilator** needed by the patients in severe respiratory distress during instances when all of Osmun's mechanical ventilators are in use or unavailable;

**WHEREAS**, the Ospital ng Muntinlupa (OsMun) requested that the **Polovent Enterprises** be allowed to extension of the existing contract for this type of service since the procurement process for the current year is still ongoing and the exigency of service requires that such service by the current provider be continued;

**WHEREAS**, as the only public hospital of the City of Muntinlupa capable of providing tertiary level health care, it is essential that the facility be enabled to contract with third party provider's equipment's crucial to sustain and save lives of our patient, when all equipment of the hospital is already in use;

**WHEREAS**, the contract price from January 1 to March 31, 2020 amounting to the said service is **Four Hundred Ninety-Eight Thousand Seven Hundred Fifty Pesos (Php498,750.00)**;

**WHEREAS**, the company shall give additional 20% discount to Senior Citizens and Person with Disability;

**WHEREAS**, the Memorandum of Agreement (MOA) entered into by the Chief Executive with **Polovent Enterprises** shall comply with the provision under Republic Act No. 9184, otherwise known as the General Procurement Act.

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the 9th Sangguniang Panlungsod of Muntinlupa, to authorize the City Mayor Atty. Jaime R. Fresnedi to enter and sign the Memorandum of Agreement (MOA) in behalf of Ospital Ng Muntinlupa (Osmun) Extension Of Contract Service with **Polovent Enterprises**, for the **Service of Mechanical Ventilator Rental Services** needed by patients in severe respiratory distress for the Months of January 1 to March 31, 2020 in the amount of **Four Hundred Ninety Eight Thousand Seven Hundred Fifty Pesos (Php498,750.00)** amount shall be taken from 2020 Executive Budget.
