WHEREAS, Article 86 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, **"the City Mayor shall represent the city in all its business transaction and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances"**;

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government Code of 1991, states that, **"xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sangguniang concerned"**;

WHEREAS, Republic Act No. 9184 or the Government Procurement Act, created the **Government Procurement Policy Board (GPPB) a body which is tasked to formulate, amend, whenever necessary, the Implementing Rules and Regulations (IRR) and the corresponding forms for Procurement**;

WHEREAS, the **Government Procurement Policy Board (GPPB)** through its Resolution No. 03-2006 approved and adopted amendment to the **Government Procurement Policy Board (GPPB) guidelines on Extension of Contracts** which reads, **"unless otherwise approved by the Government Procurement Policy Board (GPPB) and upon written request by the procuring entity, contract extension shall be allowed only on a period month to month basis not to exceed an aggregate period of six months."**;
