A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH MARCBUILT CONSTRUCTION INC., FOR THE PROJECT ASPHALT OVERLAY LOCATED AT PHASE 4, STO NIÑO VILLAGE, BARANGAY TUNASAN, MUNTINLUPA CITY IN THE AMOUNT OF SIX MILLION, THREE HUNDRED SIXTY-EIGHT THOUSAND, ONE HUNDRED SIXTY FIVE PESOS (PHP6,368,165.00) WHICH AMOUNT SHALL BE TAKEN FROM 2019 SUPPLEMENTAL BUDGET UNDER 20% COMMUNITY DEVELOPMENT FUND (CDF).

Niño Village, Barangay Tunasan, Muntinlupa Muntinlupa City* in the newspaper of general circulation and likewise posted at the Government Electronic Procurement System (GEPS) and City's Website and conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;
