FRESNEDI TO ENTER AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE CITY GOVERNMENT OF MUNTINLUPA AND BEST SECURITY AGENCY FOR THE EXTENSION OF CONTRACT OF SECURITY SERVICES IN THE AREA OF RESPONSIBILITY (AOR) FOR THE MONTHS OF JANUARY 1 TO MARCH 31, 2020, MORE SPECIFICALLY: THE MUNTINLUPA CITY PUBLIC MARKET, BARANGAY ALABANG, MUNTINLUPA CITY AMOUNTING TO SEVEN HUNDRED SIXTY THREE THOUSAND ONE HUNDRED TWENTY-FOUR PESOS AND 04/100 (PHP763,124.04).

of 1991, provides that, "the City Mayor shall represent the city in all its business transaction and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances";

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government of 1991, state that, "xxx no contract may be entered into by the Local Government Chief Executive in behalf of the Local Government Unit without prior authorization by the Sangguniang concerned";



WHEREAS, Republic Act No. 9184 or the Government Procurement Act, created the Government Procurement Policy Board (GPPB) a body which is tasked to formulate, amend, whenever necessary, the Implementing Rules and Regulations (IRR) and the corresponding forms for Procurement;

WHEREAS, the Government Procurement Policy Board (GPPB) through its Resolution No. 03-2006 approved and adopted amendment to the Government Procurement Policy Board (GPPB) guidelines on Extension of Contracts which reads, "unless otherwise approved by the Government Procurement Policy Board (GPPB) and upon written request by the procuring entity, contract extension shall be allowed only on a period month to month basis not to exceed an aggregate period of six months.";

WHEREAS, the 2019 Security & Protection Services contract between the City Government of Muntinlupa and Best Security Agency has a duration until December 31, 2019;

WHEREAS, a public bidding for the 2019 Security & Protection Services contract has been substantially undertaken by the Bids and Awards Committee;

WHEREAS, in the meantime, there is a need to extend the 2018 Security & Services contract for at least three (3) months as an emergency measure to maintain the status quo in the operations of the City Government and to avoid interruption of service;

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod of Muntinlupa City, to authorize the City Mayor Atty. Jaime R. Fresnedi to enter and sign the Memorandum of Agreement (MOA) between the City Government of Muntinlupa and Best Security Agency for the Extension of Contract of Security Services in the Area of Responsibility (OAR) for the Months of January 1 To March 31, 2020, More Specifically: The Muntinlupa City Public Market, Barangay Alabang, Muntinlupa City, amounting to Seven Hundred Sixty Three Thousand One Hundred Twenty-Four Pesos And 04/100 (Php763,124.04).


