A RESOLUTION AUTHORIZING THE CITY MAYOR ATTY. JAIME R. FRESNEDI TO ENTER AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE CITY GOVERNMENT OF MUNTINLUPA AND BEST SECURITY AGENCY FOR THE EXTENSION OF CONTRACT OF SECURITY SERVICES FOR THREE MONTHS FROM JANUARY 1 TO MARCH 31, 2020 AT THE OSPITAL NG MUNTINLUPA (OSMUN) CIVIC DRIVE, CORPORATE CITY, BRANGAY ALABANG, MUNTINLUPA CITY AMOUNTING TO TWO MILLION TWO HUNDRED FORTY-NINE THOUSAND NINE HUNDRED FOUR PESOS AND 29/100 (PHP2,249,904.29) SHALL BE TAKEN FROM 2020 EXECUTIVE BUDGET.

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, ***"the City Mayor shall represent the city in all its business transaction and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances"***;

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government of 1991, state that, ***"xxx no contract may be entered into by the Local Government Chief Executive in behalf of the Local Government Unit without prior authorization by the Sangguniang concerned"***;

WHEREAS, Republic Act No. 9184 or the Government Procurement Act, created the **Government Procurement Policy Board (GPPB)** a body which is tasked to formulate, amend, whenever necessary, the Implementing Rules and Regulations (IRR) and the corresponding forms for Procurement;

WHEREAS, the Government Procurement Policy Board (GPPB) through its Resolution No. 03-2006 approved and adopted amendment to the Government Procurement Policy Board (GPPB) guidelines on Extension of Contracts which reads, ***"unless otherwise approved by the Government Procurement Policy Board (GPPB) and upon written request by the procuring entity, contract extension shall be allowed only on a period month to month basis not to exceed an aggregate period of six months."***;

WHEREAS, provided the conditions for contract extension have been met under the said guidelines, procuring entities are allowed to extend its existing contracts for general services on a periodic month-to-month basis but not to exceed two (2) months unless otherwise approved by the Government Procurement Policy Board (GPPB);

WHEREAS, the 2019 Security & Protection Services contract between the City Government of Muntinlupa and Best Security Agency has a duration until December 31, 2019;

WHEREAS, the Best Security Agency, shall deploy Twenty-One (21) Security Guards in the Ospital ng Muntinlupa to cover 24-hour security, seven (7) days a week, under twelve-hour duty shifts based on a schedule of deployment to be prepared by the agency;

WHEREAS, in the meantime, there is a need to extend the 2018 Security & Services contract for at least three (3) months as an emergency measure to maintain the status quo in the operations of the City Government and to avoid interruption of service;

WHEREAS, the Extension of Contract shall commence from **January 1 to March 31, 2020** amounting to **Two Million Two Hundred Forty-Nine Thousand Nine Hundred Four Pesos and 29/100 (Php2,249,904.29)**;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod of Muntinlupa City, to authorize the **City Mayor Atty. Jaime R. Fresnedi** to enter and sign the **Memorandum of Agreement (MOA)** between the City Government of Muntinlupa and Security Services for the Extension of Contract for three (3) Months from January 1 to March 31, 2020 amounting to **Two Million Two Hundred Forty-Nine Thousand Nine Hundred Four Pesos and 29/100 (Php2,249,904.29)** at the Area of Responsibility (AOR): **Ospital Ng Muntinlupa (OsMun) Civic Drive, Corporate City, Brangay Alabang, Muntinlupa City**.
