A RESOLUTION REQUESTING THE METRO MANILA DEVELOPMENT AUTHORITY AND THE MUNTINLUPA TRAFFIC MANAGEMENT BUREAU TO IMPLEMENT THE NUMBER CODING SCHEME IN THE CITY OF MUNTINLUPA UNTIL THE COMPLETION OF THE SKYWAY PROJECT.

**WHEREAS**, the Metro Manila Development authority, through Regulation Numbered 96-005 also known as the Unified Vehicular Volume Reduction Program (UVVRP), regulates the operation of certain motor vehicles in all national, city and municipal roads in Metro Manila;

**WHEREAS**, the UVVRP evolved as the Number Coding Scheme (NCS) which banned vehicles from plying all the streets of Metro Manila on specific days of the week 9:00 am to 5:00 pm based on the last digit of the plate number of each vehicle;

**WHEREAS**, the City of Muntinlupa is not covered by the present NCS except the Alabang-Zapote Road and Ayala Alabang which adopted a barangay ordinance to the effect;

**WHEREAS**, San Miguel Corporation, developer of the Skyway Project, started in the later part of January 2020, Phase 2 of the project with Muntinlupa as the site for erection of pillars, rotation of pierheads, pouring of asphalt overlay and other construction which led to the nightmarish traffic jams and congestions;

**WHEREAS**, the present traffic situation prompted the City Council to declare the same as a condition of emergency necessitating the adoption of measures to reduce the volume of vehicles plying the roads of Muntinlupa;

**WHEREAS**, the implementation of the NCS will help in easing the volume of vehicles in the City;
