A RESOLUTION AUTHORIZING THE CITY MAYOR ATTY. JAIME R. FRESNEDI TO ENTER AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE CITY GOVERNMENT OF MUNTINLUPA AND BEST SECURITY AGENCY FOR THE EXTENSION OF CONTRACT FOR THREE MONTHS FROM JANUARY 1 TO MARCH 31, 2020 OF SECURITY SERVICES IN THE AREA OF RESPONSIBILITY (AOR), MORE SPECIFICALLY: THE SCHOOL DIVISION OFFICE, BARANGAY POBLACION, MUNTINLUPA CITY AMOUNTING TO NINE MILLION THREE HUNDRED SEVEN THOUSAND SIX HUNDRED THIRTY EIGHT PESOS AND 24/100 (PHP9,307,638.24) AND WHICH AMOUNT SHALL BE TAKEN FROM THE 2020 EXECUTIVE BUDGET.

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, ***"the City Mayor shall represent the city in all its business transaction and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances"***;

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government of 1991, state that, ***"xxx no contract may be entered into by the Local Government Chief Executive in behalf of the Local Government Unit without prior authorization by the Sangguniang concerned"***;

WHEREAS, Republic Act No. 9184 or the Government Procurement Act, created the **Government Procurement Policy Board (GPPB)** a body which is tasked to formulate, amend, whenever necessary, the Implementing Rules and Regulations (IRR) and the corresponding forms for Procurement;

WHEREAS, the **Government Procurement Policy Board (GPPB)** through its Resolution No. 03-2006 approved and adopted amendment to the **Government Procurement Policy Board (GPPB)** guidelines on Extension of Contracts which reads, *"unless otherwise approved by the Government Procurement Policy Board (GPPB) and upon written request by the procuring entity, contract extension shall be allowed only on a period month to month basis not to exceed an aggregate period of six months."*;

WHEREAS, the **2019 Security & Protection Services** contract between the City Government of Muntinlupa and Best Security Agency has a duration of until **December 31, 2019**;

WHEREAS, Bids and Awards Committee (BAC) undertook the opening of bid for the **2020 Security & Protection Services** contract on **February 18, 2020** and it will take some time before the contract will be awarded to the successful bidder;

WHEREAS, there is a need to extend the contract of security and protection with Best Security Agency so as not to disrupt the operation and to continuously oversee the safety of the area being mentioned;

WHEREAS, the Extension of Contract shall commence from **January 1 to March 31, 2020** amounting to **Nine Million Three Hundred Seven Thousand Six Hundred Thirty-Eight Pesos and 24/100 (Php9,307,638.24)** (computed as follows: Bid for one (1) year amounting to *Thirty-Seven Million Two Hundred Thirty Thousand Five Hundred Fifty-Two Pesos and 96/100 (Php37,230,552.96)*;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod of Muntinlupa City, to authorize the **City Mayor Atty. Jaime R. Fresnedi** to enter and sign the **Memorandum of Agreement (MOA)** between the City Government of Muntinlupa and **Best Security Agency** for the Extension of Contract of Security Services in the Area of Responsibility (AOR), more specifically: The **School Division Office, Barangay Tunasan, Muntinlupa City** Amounting to **Nine Million Three Hundred Seven Thousand Six Hundred Thirty Eight Pesos And 24/100 (Php9,307,638.24)** which amount shall be taken from the **2020 Executive Budget**.

ADOPTED, by 9th Sangguniang Panlungsod of Muntinlupa this 9th day of March 2020, on its 35th Regular Session.
