WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(vi) of the Local Government Code of 1991, provides that, "the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances";

WHEREAS, Rule IX, Article 47 of the Rules and Regulation Implementing the Local Government Code of 1991, states that, "xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sangguniang Panlungsod concerned";

WHEREAS, the 8th Sangguniang Panlungsod of Muntinlupa approved "Resolution No. 18-368, entitled, an ordinance endorsing the Development of Alabang Viaduct the fund of which shall be provided by the Local Government Support Fund Assistance to Cities (LGSF-AC) or the Green, Green, Green Program of the Department of Budget and Management (DBM) the cost and maintenance of the project should be provided by the City Government of Muntinlupa.";
